Title: Flood Control District Advisory Committee Appointment

Introduction/Background:

On February 23, 1988, the Pima County Board of Supervisors (Board), sitting as the Board of Directors for the Pima County Flood Control District (District) established the Flood Control District Advisory Committee (FCDAC). The FCDAC consists of one appointment for each Board district and each incorporated jurisdiction.

Discussion:

Josue Licea, South Tucson Planning Director, has been appointed to replace Vice Mayor Herman Lopez as the primary representative for City of South Tucson on the FCDAC. Angel Lopez will remain as South Tucson's alternate. The City of South Tucson's Mayor and Council made the appointment via Resolution No. 23-11 on May 2, 2023 (see attached).

Conclusion:

Once the Board ratifies Josue Licea, the City of South Tucson will have a new primary representative on the FCDAC. Therefore, the District is requesting the Board ratify the appointment of Josue Licea.

Recommendation:

The District recommends ratification.
