PROFESSIONAL SERVICES CONTRACT AMENDMENT

Pima County, a body politic and corporate of the State of Arizona, hereinafter called COUNTY; and Allwyn Priorities, LLC, hereinafter called CONTRACTOR, have entered into a contract, dated June 16, 2009.

WHEREAS, County requires continued qualified environmental professional services for the conduct of eligible brownfields tasks, including: encouraging public involvement and increasing community outreach; site prioritization and database development; and, environmental site assessments (ESA's); and

WHEREAS, County was awarded a Brownfields Assessment Grant from the U.S. Environmental Protection Agency (EPA), County contract No. 07-70-A-142025-0609; and

WHEREAS, County continues to require CONTRACTOR's professional environmental services to conduct Brownfields tasks; and

WHEREAS, COUNTY has reviewed CONTRACTOR's performance and finds it satisfactory; and

WHEREAS, pursuant to Article I of the Contract, COUNTY has the option to extend the Contract; and

WHEREAS, the Parties desire to extend the contract term in order to continue the contract activity for an additional one (1) year.

NOW, THEREFORE, it is agreed as follows:

A. ARTICLE I – TERM AND EXTENSION/RENEWAL/CHANGES is amended as follows:

1. The termination date is changed:

From: May, 31, 2013

To: May, 31, 2014

2. The number of available contract extensions is changed:

From: One (1)

To: Zero (0)

The effective date of this Amendment shall be June 1, 2013.

All other provisions of the Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.
