**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The reason for this resolution is that Run Tucson has requested the temporary closure of portions of Anklam Road from Speedway Boulevard to Daystar Mountain Drive and Speedway Boulevard from Anklam Road to Painted Hills Road for the Tucson 10K event on Sunday, September 17, 2017 from 6:00 A.M. to 11:00 A.M.

**Discussion:**

As a result of the request, Pima County Traffic Engineering recommends the temporary closure of portions of Anklam Road from Speedway Boulevard to Daystar Mountain Drive and Speedway Boulevard from Anklam Road to Painted Hills Road to enhance the safety of the Tucson 10K event by reducing potential vehicular conflicts.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Anklam Road from Speedway Boulevard to Daystar Mountain Drive and Speedway Boulevard from Anklam Road to Painted Hills Road to enhance the safety of the Tucson 10K event by reducing potential vehicular conflicts.

**WHEREAS**, the Pima County Board of Supervisors has determined that it will be necessary to permit the temporary closure of portions of Anklam Road from Speedway Boulevard to Daystar Mountain Drive and Speedway Boulevard from Anklam Road to Painted Hills Road to support this event,

**THEREFORE, IT IS HEREBY RESOLVED** by the Board of Supervisors of Pima County, Arizona, that:


