**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The reason for this resolution is that Ken Montaney has requested the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail for the Colossal Cave Road Race event on March 11, 2018 from 6:00 A.M. to 4:00 P.M.

**Discussion:**

As a result of the request and Special Event Permit Application review, Pima County Department of Transportation recommends the temporary closure of portions of Pistol Hill Road from Colossal Cave Road to Old Spanish Trail.

**Conclusion:**

2. All applicable County officers and employees are hereby authorized and directed to perform all acts necessary or desirable to give effect to this Resolution.


