2. Legal advice and discussion regarding the possible purchase of downtown properties. While Pima County encompasses the City of Tucson, purchases of property should remain outside the City limits. THINK CAREFULLY WHEN SPENDING TAXPAYER FUNDS

COUNTY ADMINISTRATOR

5. Constable, Justice Precinct 4—Discussion/Direction/Action regarding whether to proceed with the appointment to fill the vacancy of the position of Constable, Justice Precinct 4.

Military members are well aware of the definition of RIF. The county should be pursuing the "reduction in force" mantra due to the inability to have a reasonable budget. **VOTE AGAINST THIS ITEM**

But thanks to the Sheriff's Department, the Recorder's Office and Behavioral Health, all of which lowered their May expenditure forecasts compared to the February Forecast helping curb our budget woes.

FACILITIES MANAGEMENT

19. Catholic Community Services of SO AZ, Inc, to provide a cooperative agreement for provision of humanitarian services, no cost.

No cost? This replaces a previous cooperative agreement with some funding by FEMA for CCS humanitarian services (read this: housing illegals) at the Ajo Way facility which is owned by the County. And it is at a cost to taxpayers - don't try to fool us. **VOTE AGAINST THIS ITEM**

PROCUREMENT

26. Burgess & Niple, Inc., to provide for Pima County Safe Streets for All: Creating a Culture of Safety for our Community Project, U.S. DOT FHWA SS4A Grant Fund, contract amount \$1,380,959.77/2 year term (CT-TR-24-430) Administering Department: Transportation

AGAIN, Stop this silliness. Just because we can receive a grant doesn't mean it's a viable issue - and research into what it will cost the County to accept this grant should be undertaken. Aren't there already County agencies working on protecting the safety of our citizens? Will they be disbanded? **VOTE AGAINST THIS ITEM**
