WIOA Title 1 Adult, Dislocated Worker, and Youth Programs

#### \*Purpose

Funds are used to provide Workforce Innovation and Opportunity Act (WIOA) services to adults, youth and dislocated workers who are seeking employment or job skills training that can lead to employment. Services include case management, training, and support services to assist adult, youth and dislocated worker job seekers in finding employment. This is a no-cost amendment to replace the 29.0 Discrimination clause.
