Project Title / Description: Ajo Youth/Teen Archery Program

Purpose: Pima County Parks & Recreation is launching a Youth/Teen Archery Program in Ajo, AZ, taught using the National Archery in the Schools Program (NASP) curriculum. This evidence-based curriculum has proven successful in building confidence, focus, and physical skills in youth ages 7–16. Our program will utilize our newly renovated indoor gym facility, allowing for year-round instruction regardless of weather conditions.

Program Goals/Predicted
Outcomes: Provide safe, structured, and inclusive archery instruction to youth and teens in Ajo. Increase physical activity levels and promote healthy lifestyles among participants. Teach discipline, focus, and goal-setting skills. Foster a sense of community and belonging through participation in a unique sport.

Public Benefit and Impact: This program will serve youth and teens ages 7–16 in the rural community of Ajo, AZ, and surrounding areas. Ajo is a geographically isolated community with limited recreational options for youth. Our target population includes local students, homeschool families, and underserved youth who may not otherwise have access to structured sports programs. We anticipate serving approximately 40–60 participants in the first year, with multiple sessions and classes offered to ensure broad community access.
