*Project Title/Description:

Pima County Teen Court

*Purpose:

The Board of Supervisors approved funds of \$29,368 for the Pima County Teen Court program at the June 22, 2021 meeting. YWCA of Southern Arizona requested additional funds of \$10,000 for operational purposes due to COVID-19. This program is an alternative to prosecution through the juvenile court system. The program uses a peer engagement and restorative justice models to help the offending youth in skill-building and other community service learning activities to avoid recidivism. This Amendment will add the \$29,368 approved June 22 plus the additional \$10,000, and renew CT-21-079 for an additional year. The resulting total funding over the two-year term will be \$65,648.

*Program Goals/Predicted Outcomes:

Program Goal: Agency will provide 200 hours of training/skill development to 50 unduplicated individuals.

Program Outcome: At a minimum, 50 participants will reduce their involvement with peers who exhibit and encourage negative behaviors and use alcohol or drugs. As a result, at-risk behaviors by the participant will decrease.

*Public Benefit:

The program promotes economic development of the County residents by reducing costs associated with traditional juvenile justice programs and improving the potential for juveniles to participate in the community.

*Metrics Available to Measure Performance:

Agency will submit quarterly reports which include the number of units served, number of deliverables to unduplicated participants, and the number of unduplicated participants that have met the expected performance.

*Retroactive:

Yes. Finalizing documentation and re-confirmation of budget were in part issues that caused contract processing delays. If this amendment is not approved, the services will not be provided.

AMENDMENT ONE

Background and Purpose. 1.

- 1.1. Background. On June 9, 2020, Pima County ("County") and YWCA of Southern Arizona ("Agency"), entered into the above referenced Agreement to provide offending youth with skillbuilding and other community service learning activities to avoid recidivism County (the "Programs" or "Agency's Programs").
- 1.2. Purpose. County has completed its 2020-2021 Outside Agency budget review process and wants to extend the Programs for an additional year and allocate funding to continue the Program(s). After review of Agency's performance and provision of Program services, County finds that the community will benefit from continued Program services provided by Agency. County is awarding additional funds because Agency's performance is satisfactory, and Agency has the capacity to continue to provide Program services.
- Term and Extension. County is exercising the Extension Option in Paragraph 2.2 to extend this 2. Agreement for one additional year commencing on July 1, 2021 and terminating on June 30, 2022. If the commencement date is before the effective date of this amendment, the parties will, for all purposes, deem the amendment to have been in effect as of the commencement date.
- Compensation and Payment. The maximum allocated amount in Paragraph 4.1 is increased by 3. \$39,368.00. County's total payments to Agency under this Agreement will not exceed \$65,648.00.
