ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

Amendment # 2, Master Agreement # MA-PO-1300000000000000167, Weber Water Resources, LLC & Yellow Jacket Drilling Services, LLC to provide job order construction services under Job Order Master Agreement for Well Installation, Development, and Repair Services. This Amendment extends the term of the Agreement for one year and increases the Agreement Amount by \$550,000.00. Funding source: Various Funds Administering Department: Natural Resources, Parks and Recreation Department.

ARTICLE I – BASIC TERMS of this Master Agreement (Agreement), as originally approved by the Board of Supervisors, provides for the ability extend the contract term or to add funding to this Agreement at any time without the approval or consent of the Job Order Contractors.

As of October 6, 2014, approximately \$87,000.00 of available spending authority remains in the Agreement. The major using departments, NRPR, RWRD, and DEQ, have projected that the addition of \$550,000.00 to the Agreement value will be sufficient to provide for the as-needed provision of well installation, development and repair services during the renewal period.

Under this Agreement, Jobs below \$10,000 are negotiated individually with whichever JOC contractor is selected by the using department. All federally funded jobs and jobs above \$10,000 must be competed between the JOC contractors, with the job order being awarded to the low cost JOC contractor. Jobs exceeding \$100,000 must be competitively solicited.

MASTER AGREEMENT AMENDMENT

WHEREAS, COUNTY and CONTRACTORS have entered into the Master Agreement referenced above; and

WHEREAS, COUNTY has a continuing need for these services; and

WHEREAS, Article I – Basic Terms of this Agreement provides for COUNTY, at its sole discretion, to unilaterally extend the term or add funding; and

WHEREAS, COUNTY wishes to increase funding to provide payment for well installation, development and repair services during the renewal period; and

WHEREAS, COUNTY notified CONTRACTORS of intent to extend this Agreement for one year and add funding, and CONTRACTORS acknowledged notice of these intended actions.

NOW, THEREFORE, it is agreed as follows:

1. CHANGE the first sentence of paragraph one of ARTICLE I – BASIC TERMS as follows:

FROM: "...shall commence on December 1, 2012 and shall terminate on November 30, 2014, unless sooner terminated..."

TO: "...shall commence on December 1, 2012 and shall terminate on November 30, 2015, unless sooner terminated..."

2. This Amendment adds \$550,000.00 to the not to exceed amount of this Agreement. The new total not to exceed amount of this Agreement is \$1,090,000.00.

This Amendment shall be effective on December 1, 2014.

All other provisions of the Agreement, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.


