Low Bid: Award of Contract, Requisition No. 83510, in the amount of \$5,007,831.96, Base Bid plus Add Alternate No. 1 – Pedestrian Path and Add Alternate No. 2 - Landscape, to the lowest responsive bidder, Southern Arizona Paving & Construction Co., (Headquarters at Tucson, Arizona), for the construction of Orange Grove Road, Camino de la Tierra to La Cholla Boulevard Project. The contract term is thirty months with the ability to extend the term for contract completion. Construction is to be complete within 270 working days from Notice to Proceed.
