Project Title/Description:

Pima County Public Library State Grants-in-Aid 2017 designated amount for Pima County through State Grants-in-Aid appropriations directed at public libraries for current fiscal year.

Purpose:

Funding will support a second Leadership Cohort of 20 additional library staff members. Pima County Public Library has contracted with Sam McBane Mulford and Cheryl Gould, to deliver a leadership and staff development program. Cohort 2 will participate in a mix of workshops, discussions and experiential learning related to building the Library's capacity for leadership and organizational effectiveness.
