Dear Board of Supervisors,

On behalf of the Vail Community Action Board, the Greater Vail Chamber of Commerce, Vail Preservation Society, Colossal Cave Mountain Park and the residents of Vail we are requesting that some reallocation of funds from the \$5 million in road repair maintenance be used to make repairs to the section of Colossal Cave Road between Old Vail Middle School and I-10.

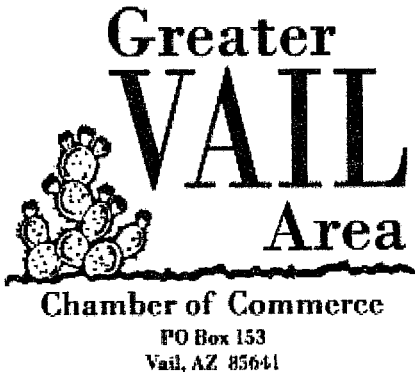
This crumbling section of road includes a blind intersection, no turn lanes for school access, no bike lanes, and no sidewalks. It is a danger to our residents commuting to and from work, our cycling enthusiasts (not only recreational but also professional cyclist who train here), and most important our children's walking or cycling to and from school. Acacia and Old Vail Middle Schools are in need of right and left turn lanes which would greatly improve congestion, improve traffic flow, and provide a safer environment for pedestrians. We acknowledge the limitation on funds, but this is a very important road that has an impact on county holdings, tourism, and future growth in Vail.

The residents of Vail have been waiting many years for repairs and improvements that would accommodate the growth in the area. We are asking for some of the money to address the needed changes that will have a positive impact for our residents, business and schools.

500 properties with County roads

Our roads classified several years ago as in very poor or failed condition. Today's summary – abysmal

Attempt to slow deterioration by constant calls about pot holes, however we are now repairing the pot holes *previously repaired!*
Presently collecting signatures on a petition for road improvement – 1/3 of our property owners have signed in first two weeks

Take no comfort in knowing that we share these conditions with $\frac{3}{4}$ of the County's roads

Is it really possible that neglect of our infrastructure has brought us to this point – only $\frac{1}{4}$ of our roads are in good condition?

We ask that you go back to first principles which demand sound infrastructure, without which there is no basis for a healthy and growing community. **How can you possibly secure the safety and pursuit of livelihood in our area without a sound road system?**

Roads, bridges, drainage MUST come before any other dollar is spent.

Please refrain from expenditures of our money that do not contribute to a sound infrastructure, without which you will only further jeopardized this area's future.

It is past time to put the horse back in front of the cart.
