Dear Supervisor Miller:

I am transmitting this letter to advise you of our moving-forward steps on the above four (4) comprehensive plan amendment applications and to, as a result of the work involved, respectfully request that all four of these cases be continued from the currently scheduled Board of Supervisors meeting on 21 January to the Board meeting of February 18, 2014.

In response to the comments and direction we received from the Board at our original meeting of November 19th, we have developed a new framework of enhanced natural area set-asides and natural buffers next to the existing residential developments; this will both increase the overall amount of CLS mitigation provided across the four parcels, as well as achieve proper protections and setbacks from the existing nearby residential subdivisions.

We are currently finalizing all of our calculations and graphics to illustrate the above and will be transmitting updated materials to staff to incorporate into your Board packets on these comprehensive plan items. We are also scheduled to meet with Carolyn Campbell of the Coalition for Sonoran Desert Protection during the week of January 20th to review and discuss the new materials and open space set-asides.

Lastly, I will be inviting the interested neighbors to attend small-group meetings to similarly review the new materials and discuss the buffering and setbacks we propose. It is my intent to have these neighbor meetings during the last week of January and the first week of February. I will extend our invitations to them prior to the 21 January Board of Supervisors meeting and make them fully aware of our request to continue that hearing to the February 18th date.


