Re:

Duplication of Pima County Programs and/or Services

Supervisor Lee requested an analysis of external services or programs that may represent a duplication of internal Pima County effort and funding. This task has proven to be considerably more complex than staff had anticipated, and we are still very much in the discovery phase. There are thousands of contracts where the County engages an external vendor for services or programs. In some cases these are activities that the County is currently undertaking itself, others involve an external vendor augmenting County capacity, and some involve highly specialized or legally required services that require an external vendor. An additional complexity is the varied source of funding for these contracts which include the general fund, grant funding or other special revenue sources.

Attached please find exemplars from Behavioral Health, Community & Workforce Development, Health Department and Pima Animal Care Center.

Staff requests additional time to complete the necessary review in a way that is responsive to the Board of Supervisors' intent.
