**AMENDMENT**

THIS CONTRACT hereinafter called "Contract", entered into and between Pima County, a body politic and corporate of the State of Arizona, hereinafter called "County"; and International Sonoran Desert Alliance, an Arizona non-profit corporation, hereinafter called "Contractor".

WHEREAS, County finds that there is a continued need for education achievement and services that will improve the economic welfare of the County inhabitants; and

WHEREAS, the Parties mutually agree to increase funding for the provision of additional services.

NOW, THEREFORE, COUNTY and CONTRACTOR agree to amend the Contract as follows:
