To the Pima County Board of Supervisors

Today, 12/12/16, the Green Valley Council Planning and Architecture Committee voted to recommend to the Board of Supervisors that the site of a proposed cell tower in Green Valley be at the parking lot of the San Ignacio Golf Club. I urge you to support and vote in favor of this recommendation. A cell tower at this location will be significantly lower (58 feet in height rather than 95 feet) and will minimize to a much greater degree the adverse impact on skylines and mountain backdrops to a vastly larger number of home owners than the alternative location. Additionally the location at the golf course parking lot is considerably more consistent with the Pima County Ordinance (18.07.030) that pertains to placement of communication towers.

I thank you and appreciate your taking my input on this issue.
