Title: Election Board Worker Appointments

Introduction / Background: The Elections Department recruits board workers (poll workers) for each of the vote center locations being used on Election Day. Each election board consists of equitable representation from Pima County's two major political parties as outlined in A.R.S. §16-531.

Discussion: A.R.S. §16-531(A) requires the Board of Supervisors to appoint election board workers for each vote center not less than twenty days before a general or primary election. The Elections Department has secured 59 vote center locations for the Special General Election on September 23, 2025, and has staffed the locations with board workers accordingly.

Conclusion: By approving the appointment of the election boards for the Special General Election on September 23, 2025, the Board of Supervisors and the Elections Department will be in compliance with A.R.S. §16-531.

Recommendation: The Elections Department recommends the approval of election board workers for the Special Primary Election on September 23, 2025, as proposed.

Fiscal Impact: Board workers are paid a stipend, as approved by the Board of Supervisors, utilizing funds from the Elections Department's annual budget.


