

Pima County a body politic and corporate of the State of Arizona ("County") and Tucson Youth Development (TYD), Inc. ("Contractor") have entered into the above referenced contract to implement the Youth CareerConnect program.

AMENDMENT

- A. Pima County Board of Supervisors finds that continuing to provide workforce development services for youth and adults in Southern Arizona is in the best interests of the County.
- B. County has reviewed Contractor's performance and finds it satisfactory.
- C. Parties agree to extend the Contract for the provision of services through June 30, 2017.

NOW, THEREFORE, COUNTY and CONTRACTOR agree to amend the Contract as follows:

1. **ARTICLE I – TERM AND EXTENSIONS**, Paragraph A, is amended follows:

- A. The termination date is changed:
FROM: June 30, 2016
TO: June 30, 2017
- B. The number of available extensions is changed:
FROM: two (2) 12-month periods or any portion thereof
TO: one (1) 12-month period or any portion thereof

2. **ARTICLE III – COMPENSATION AND PAYMENT**, Paragraph A, is amended to increase the not-to-exceed amount:

FROM: \$644,500.00
TO: \$944,500.00

3. **EXHIBIT A – SCOPE OF WORK, V. BUDGET**, Paragraph A, is amended to delete the budget table and replace with the following:






