**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

On Your Left Fitness has requested the temporary closure of portions of La Canada Drive from Calle Concordia to Rancho Feliz Drive and Calle Concordia from La Canada Drive to Calle Loma Linda for the Oro Valley Sprint Triathlon & Duathlon Festival event on March 23, 2019 from 5:00 A.M. to 1:00 P.M.
