**\*Title:**

Arizona Game and Fish Shooting Range Development Grant

**\*Introduction/Background:**

Arizona Game and Fish (AGF) created the Shooting Range Development Grant Program (SRGP) to encourage the development and improvement of shooting ranges and to support their maintenance and operation. Pima County has previously applied for SRGP funding to support its shooting centers.

**\*Discussion:**

AGF requires applicants to include a Resolution from their governing group approving the submission of an application to the SRGP. The Resolution affirms the Board's approval to file an application; certifies the application is consistent and compatible with all adopted plans and programs for safe shooting range development; agrees to comply with all procedures, guidelines and requirements of AGF as part of the application process; and understands that scope and funding are subject to final approval by AGFC.

**\*Conclusion:**

NRPR operates several ranges, including the Southeast Regional Park Shooting Range, offering Pima County residents safe, environmentally sound shooting opportunities. These sites need maintenance and security improvements to ensure their continued use and to prevent break-ins and thefts. The SRGP offers the County an opportunity to invest in security and safety improvements. To apply for this grant, the County must have a Resolution of approval from its Board of Supervisors.

**\*Recommendation:**

The Board of Supervisors should approve the Resolution authorizing NRPR's application to the SRGP program.

**\*Fiscal Impact:**



**The Board of Supervisors of Pima County, Arizona, finds:**

1. The Arizona Game and Fish Commission under A.R.S. §17-231 has authorized the establishment of a Shooting Range Development Policy providing financial assistance for the development of shooting ranges for public purposes.
