**CONTRACT AMENDMENT # 5**

The parties agree to amend the above-referenced contract as follows:

**1. Background and Purpose.**

1.1. Background. On July 13, 2021, County and Contractor entered into the above referenced agreement to provide legal representation of the Pima County Sheriff's Department, Sheriff Chris Nanos, Sergeant Mosely, and Deputy Caudillo pertaining to the attempted arrest and shooting of Bradley Lewis.

1.2. Purpose. County requires continuing services and requires additional funds to perform those services, commencing February 6, 2024.

**2. Maximum Payment Amount.** The maximum amount the County will spend under this Contract, as set forth in Section 5.2, is increased by \$100,000.00. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$350,000.00.
