CONTRACT AMENDMENT

WHEREAS, COUNTY and CONTRACTOR entered into a Contract for services as referenced above; and

WHEREAS, CONTRACTOR and COUNTY, pursuant to Article 3 - Term, have agreed to extend the Contract term for a period of one year; and

WHEREAS, CONTRACTOR and COUNTY, pursuant to Article 5.1 - Fees, have agreed to increase the contract amount to allow payment for the continued provision of Dispatch Services during the extended term of the contract; and

WHEREAS, CONTRACTOR and COUNTY pursuant to Article 6 – Radio System Operation and Coverage, have agreed to accept equipment update;

NOW, THEREFORE, it is agreed as follows:

CHANGE: ARTICLE 3 - Term:

From: "... shall terminate on the 30th day of June 2014..."

To: "... shall terminate on the 30th day of June 2015..."

CHANGE: ARTICLE 5 – 5.1 Fees:

From: "Total payment for this Contract shall not exceed \$146,000.00."

To: "Total payment for this Contract shall not exceed \$730,000.00."

CHANGE: ARTICLE 6 – Radio System Operation and Coverage:

From: "use of the Pima County E.F. Johnson Multi-Net II, 800 MHz."

To: "use of the Pima County Motorola ASTRO25 P25 radio system."

CHANGE: ARTICLE 6 – Radio System Operation and Coverage:

From: "...subscriber equipment to use on the E.F. Johnson system."

To: "...subscriber equipment to use on the Motorola system."

The effective date of this Amendment shall be July 1, 2014.
