I cannot tell you how important this is for the general public's health, our beautiful Santa Ritas that host lots of outdoor activities, the health and well-being of the communities just south of Tucson who will be directly exposed to the harmful effects of heavy commercial truck traffic, our future water supplies, and the overall appeal of our area to its residents and tourists. You should be proactive in helping all of us who live in Pima County and **vote yes**.

We understand that Hudbay Minerals, a Canadian company, is against the ordinance, but of course we all understand why. Hudbay intends to construct open-pit mines just south of Tucson next to the Santa Rita Mountains, along with Mitsubishi's help. Mitsubishi, a Japanese company, recently invested \$600 million for a 30 per cent interest in Hudbay's Copper World to keep this project alive. Apparently, Hudbay was having some financial problems that jeopardized Copper World, so Mitsubishi stepped up, helping to ensure a copper supply for Japan. In any case, Hudbay and Mitsubishi will export all the copper for smelting and refining outside the USA. How cynical of Hudbay and Mitsubishi!

We live in the Catalina Foothills and are not directly affected by Hudbay's open-pit mines, but we understand the impact it will have on all of us, especially the communities south of Tucson and our beautiful Santa Rita Mountains, most likely affecting the air for much of the area because of heavy commercial truck traffic.

Last, my husband and I have given significant financial support to efforts to stop this ill-conceived project because we love the Tucson area. Copper World will again negatively affect all of us around Tucson, our health, our beautiful mountains that host lots of outdoor activities, the communities just south of Tucson and the Tucson area, our water supplies, and the overall appeal of the area to its residents and tourists.


It is imperative that the county close a loophole that has allowed businesses to operate an unlimited number of heavy trucks across unpaved roads that can negatively impact air quality.

Heavy trucks generate five to 10 times the amount of airborne dust from unpaved roads compared with passenger cars. This dust can contain dangerous contaminants that can cause lung infections that can lead to serious and fatal disease.

My wife, Deborah, has a severely compromised respiratory system. Degrading our air quality with a constant stream of heavy trucks will be very detrimental to her health. We believe that incidents of Valley Fever in Green Valley and Sahuarita will spike with particulates kicked up by these trucks and spread over a wide area by wind. These trucks will not only lower air quality but the quality of life in our communities.

Reducing the amount of airborne dust caused by heavy trucks traveling across unpaved county roads is a proactive measure Supervisors can take to improve the quality of life throughout Pima County. Please pass Ordinance No. 2025-32.




