*Purpose:

Amendment of Award: Master Agreement No. MA-PO-22-080, Amendment No. 04. This Amendment is for a one-time increase in the amount of \$1,005,000.00 for a cumulative not-to-exceed contract amount of \$3,400,000.00, and effective 02/15/2024 increases the annual award amount by \$230,000.00 from \$270,000.00 to \$500,000.00. This increase is required to purchase additional equipment to support new and existing poll locations. Administering Department: Elections and Information Technology.

*Procurement Method:

Pursuant to Pima County Procurement Code 11.12.050, Sole source procurement, on 02/15/2022, the Board of Supervisors approved an award of contract for an initial term of one (1) year in the award amount of \$1,500,000.00 with three (3) one-year renewal options in the annual award amount of \$270,000.00.

On 07/05/2022, the Board of Supervisors approved Amendment No. 01, which increased the not-to-exceed contract amount by \$625,000.00 for a cumulative not-to-exceed contract amount of \$2,125,000.00. This increase was required to purchase alternative printers once the originally quoted printers were no longer available.

On 10/18/2022, the Board of Supervisors retroactively approved Amendment No. 02, which added additional onsite support to prepare and ensure full equipment functionality prior to the then upcoming election and appended the contract with the Forced Labor of Ethnic Uyghurs language pursuant to A.R.S. § 35-394.

On 01/18/2023, the Procurement Director approved Amendment No. 03, which extended the termination date to 02/14/2024, increased the Onsite Support Rate from \$2,200.00 to \$2,800.00, introduced an Onsite Support Rate Upcharge (to be quoted as needed), and added the annual award amount of \$270,000.00 for a cumulative not-to-exceed contract amount of \$2,395,000.00. Two (2) renewal options remained.

CONTRACT AMENDMENT

The parties agree to amend the above-referenced contract as follows:

1. Background and Purpose.

- 1.1. <u>Background</u>. On February 15, 2022, County and Contractor entered into the above referenced agreement to provide the implementation and continuing maintenance for Tenex Election Desk and Precinct Central Electronic Poll Book.
- 1.2. <u>Purpose</u>. County requires the purchase of additional equipment to support new and existing poll locations.
- 2. Maximum Payment Amount. The maximum amount the County will spend under this Contract, as set forth in Section 5.2, is increased by \$ 1,005,000.00 for the purchase of the additional equipment. County's total payments to Contractor under this contract, including any sales taxes, will not exceed \$ 3,400,000.00. County's annual payments to Contractor for ongoing software services under this Contract, including any sales taxes, may not increase the NTE Amount by more than \$500,000.00 per year.
- 3. Additional Equipment. County may purchase the additional equipment at the rates established in Exhibit D: Tenex Precinct Central & Air Ballot Quotes (4 pages).
