Hi Pima County Board of Supervisors,

I want to voice my opinion in favor of installing a mask requirement in our schools. I know you will be getting many emails and phone calls about this issue. I know that the "unmask our kids" crowd is passionate as well. Especially with the highly infectious Delta variant circulating, not requiring masks indoors could be a recipe for disaster. Just one infected child could spread the virus to an entire class, especially in elementary schools where no children are yet vaccinated.

This is why both the CDC and the Academy of American Pediatrics strongly recommend masks for unvaccinated children in schools at this point in the pandemic. I have 2 children who fall into this category who I love with all of my being. They are not just a statistic, they are my actual children.

Many are saying that the reason why we can drop the mask mandate inside school buildings is because children are at minimal risk for severe COVID. This is true, to some extent. Yet at the same time, the CDC has data showing that among adolescents who were hospitalized with COVID this past spring, a third were admitted to the ICU and 5% required ventilation. We are seeing huge hospitalization spikes in children who have caught the Delta variant, including children admitted to intensive care units. Over 400 children have died so far of COVID-19. I am a parent with Even a cold spins me into I NEED to be here to raise my children. I beg of you to require masks again in our schools.

Last school year proved that kids could go to school and remain safe, even during a global pandemic. Why was this possible? MASKS. Masks worked last school year, and most children adapted well. And part of the reason masks worked well is because all children and staff wore them inside diligently. Yes, it is annoying. But this is not about preference or comfort. This is about safety. If we continue with a maskless or mask-optional environment, especially among children under 12, we risk losing that safety measure that so many of us desire and deserve for our children. Again, all it takes is one maskless, infected individual to spread the virus to many.

This is also about education. After the learning delays of last year fumbling through virtual classrooms, hybrid schedules, etc. there is rapid learning loss. Closing classrooms due to COVID puts our students at a disadvantage. Every time a student is out sick for 2+ weeks or a classroom gets shut down, there are massive effects to education. Our future depends on our children having access to safe, in-person classrooms. Masks are proven to be effective at lowering COVID transmission, thereby aiding in our goal of actually educating our kids. Let's team up and help our kids learn by requiring masks, and please not return to the dark days of isolation and poor education via a computer cable.

Mask Mandate for K-12 Schools: Support

I wish that I had seen the call-in option for the Board meeting this morning, as I would have called in to voice my support of the mask mandate in K-12 schools.

As a parent of two children in schools in Pima County, I am extremely concerned about the Delta variant and how it is impacting children. This variant is stronger and has led to an increase in the number of pediatric admissions, something that wasn't seen with the previous COVID variants. Multiple members of the health community are concerned about this trend, especially since the majority of children are unable to be vaccinated at this point. More than 18% of the new cases in Pima County since July 1 are in people 16 and younger. Banner Health, Arizona's largest health care system, admitted 71 COVID-19 positive pediatric patients in July, which was double the number it admitted in June, Banner's chief clinical officer Dr. Marjorie Bessel said during a briefing last week. Last week, the American Academy of Pediatrics wrote a letter to the FDA urging them to approve the vaccine for 5-12 year olds due to the pressing risk the Delta variant carries. Until this happens though, masking is the easiest thing we can do to protect our children.

We have seen, in multiple school districts across the state, that a "recommended" policy simply does not work. Reviewing the Maricopa County COVID-19 School dashboard, most areas are experiencing substantial transmission. School districts have already had to move some classes to virtual learning. And this is just after a couple weeks of being in school. With the start of school last week, we have the opportunity to not put our students at the same risk with the passage of a mask mandate. We have seen the writing on the wall, not just in Maricopa County, but across the country. Let's not wait to take action until it arrives in our backyard.

Additionally, Tucson Unified School District, The University of Arizona and several other school districts across the State have already passed a mask mandate. They have decided that the health and safety of our children supersedes a law based in politics and not science. I implore that you decide to choose the same.



I am writing as a concerned parent and physician in the Tucson community. My wife and I attended (virtually) the last board meeting where you expressed your concerns about mandating masks in school and ultimately voted 'NO'. Since the last meeting 6 days ago the number of COVID cases has exponentially increased. My kids' school has reported positive cases in almost every grade so far (in just 14 days of school) which resulted in quarantine for some children for at least 7 days with no option for virtual learning. Not only are we robbing these children of a healthy environment, but we are also denying a fit education as a result. Please do the right thing and mandate masks in Pima County.

We have mitigated COVID spread in my clinic simply by mandating masks, particularly because we can not maintain physical distancing. Why should it be any different where unvaccinated children gather for 8+ hours a day without physical distancing? Can you explain a person's "right to not wear a mask" to a parent whose child is intubated in the ICU after contracting COVID from school exposure? Could you live with yourself knowing that you had a chance to try everything in your power to prevent even one case but you didn't do so?

Why have so many schools in AZ stepped up and mandated masks anyway? Because they put lives before politics. Please do the right thing and vote YES for mask mandate in schools K-12 in Pima County.

I am the mom of a kindergartener at Ventana Vista Elementary School within Catalina Foothills school district, and I am deeply concerned about the "mask optional" policy within the schools. I understand that this is our current law, but I've also read that it is "unconstitutional," and might be challengeable. This is not the time to play political games with our vulnerable children, who haven't had the opportunity yet to get the covid vaccine. Both the CDC and AAP are recommending that all people, vaccinated or unvaccinated, wear masks while indoors to prevent transmission of the delta variant at this time; it's more contagious and spreading like wildfire. I want my child to be in a stable school this year, not in a school which has to open and close constantly due to outbreaks from the virus.

I also do not want to see children suffer from "long covid," need to be hospitalized in the ICU, or worse die from this nasty virus. According to the CDC and AAP, all people need to be wearing a mask indoors to prevent transmission, unless eating or drinking. Let's all just stick with what's well within our rights and stop meddling with education that's already been decimated!!




he endured his entire infancy.
