**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

On Your Left Fitness has requested the temporary closure of portions of La Canada Drive from Calle Concordia to Rancho Feliz Drive and portions of Calle Concordia from La Canada Drive to Calle Loma Linda for the Oro Valley Sprint Triathlon/Duathlon on Saturday, March 25, 2017 from 5:30 A.M. to 1:00 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour route, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of La Canada Drive from Calle Concordia to Rancho Feliz Drive and portions of Calle Concordia from La Canada Drive to Calle Loma Linda to enhance the safety of the Oro Valley Sprint Triathlon/Duathlon by reducing potential vehicular conflicts.


