***Project Title/Description:**

Community Action Services Program

***Purpose:**

Pima County received federal funds from the Arizona Department of Economic Security (ADES) to provide rent, mortgage, and utility assistance, case management and navigation to low-income individuals and families facing eviction or homelessness. Services provide assistance and assess the needs of low-income clients to determine the incremental steps the client must take to move toward self-sufficiency. In addition to direct assistance, the available services encompass coordination, community services, case management, and navigation. State Fiscal Year 2025 allocation is as follows: Short Term Crisis Services/Temporary Assistance To Needy Families (STCS/TANF) - \$540,565.00, Low Income Home Energy Assistance Program (LIHEAP) A-16 - \$270,647.00, LIHEAP Navigator \$349,684.64 (includes the remaining allocation for the FY), Community Services Block Grant (CSBG) - \$1,211,332.21 (includes estimated CSBG carryover) and Neighbors Helping Neighbors (NHN) - \$6,210.00.

This ADES Amendment is to add the initial Itemized Service Budget for the period of July 1, 2024 through June 30, 2025.

Indirect cost: STCS/TANF, LIHEAP and CSBG 10% de minimis. 15% is not negotiable because this was procured prior to October 1, 2024. NHN does not allow indirect costs.

***Procurement Method:**

The grant award amendment was reviewed and signed by the Pima County Attorney Office.

***Program Goals/Predicted Outcomes:**

The program goal is to alleviate poverty through navigation and case management and by providing emergency services.

***Public Benefit:**

The benefit of this program to Pima County residents is to provide case management, prevent evictions, foreclosures and utility shutoffs for low-income residents; address food insecurity, provide emergency medical prescriptions, minor home repair and other special needs in rural communities.

***Metrics Available to Measure Performance:**

Monthly case management and navigation reports, quarterly Results Oriented Management & Accountability (ROMA) reports, CSBG Annual Report and the Community Action Plan.

***Retroactive:**

Yes, to July 1, 2024 to coincide with the term of the award. The County received the amendment from ADES on December 23, 2024. The next available Pima County Board of Supervisors meeting the amendment could be placed on is January 21, 2025. If the amendment is not approved, eligible individuals and families would not receive emergency services.
