# We are writing to express our strong support for the appointment of Andrés Cano to fill the District 5 vacancy on the Pima County Board of Supervisors.

As long-time environmental advocates and contributors to the development of the Sonoran Desert Conservation Plan, we care deeply about the future of Pima County's open spaces, clean air and water, and regional sustainability.
