Dear Chair Grijalva, Honorable Members of the Board of Supervisors, and Madam Clerk,

It is with great pride that I offer my recommendation on behalf of Kristen Randell to the Board of Supervisors. I first meet Ms. Randell when she was serving as a Constable for Pima County in Summer of 2020 as COVID was creating havoc in our community. During this time Evictions were increasing at an exponential rate. Tensions were high across the County. We met to determine how the Constables and the Justices of the Peace could work together to mitigate confusion and difficulties. I was impressed with her dedication, intelligence and grasp of the subject matter. She came with a plan regarding information distribution for Defendants and a simple ask for how Justices could be of assistance. The plan itself was low cost mostly utilizing her own effort and small changes in case processing. I know that her plan assisted many across the County.

It has been a great pleasure to watch her apply her many skills to Green Valley Justice Court. Under her guidance as Court Administrator that Court has become a model for others to follow. Ms. Randell improved the Court functions already in place. She has also created new programs, such as the DUI treatment Court, a mediation program and is working to create a justice center. All these projects demonstrate her ability in working with many stakeholders as well as creative governance applied to complex problems. Ms. Randell has also lent a hand in assisting Judge Williams of Ajo Justice Court in revitalizing that Court after a long period of stagnation.

Given the importance of the Judicial branch here in Pima County, as well as the Court's ever-increasing percentage of the budget, I believe it is vital to have someone of Ms. Randell's abilities on the Board of Supervisors. She understands how the Judicial Branch functions and how to use resources to their fullest.

I recommend Ms. Kristen Randell for the Board of Supervisors District 3 seat without reservation.
