**Title:** Temporary Road Closure Resolution

**Introduction/Background:**

The Perimeter Bicycling Association of America has requested the temporary closure of portions of Snyder Road between Sabino Canyon Road and Melpomene Way for the annual El Tour De Tucson on Saturday, November 21, 2015 from 7:30 A.M. to 2:00 P.M.

**Discussion:**

As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour routes, if needed due to inclement weather or other circumstances are recommended to facilitate the event.

**Conclusion:**

Pima County Traffic Engineering recommends the temporary closure of portions of Snyder Road between Sabino Canyon Road and Melpomene Way to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.

Pima County Traffic Engineering recommends approval of this resolution to temporarily close portions of Snyder Road for the El Tour De Tucson on November 21, 2015 from 7:30 A.M. to 2:00 P.M.


