RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS CANCELING THE ELECTION FOR DISTRICT BOARD MEMBERS OF THE WHY DOMESTIC WATER IMPROVEMENT DISTRICT AND APPOINTING LINDA P. HOOD AND AMIE MANUEL TO THE WHY DOMESTIC WATER IMPROVEMENT DISTRICT BOARD OF DIRECTORS.

WHEREAS, the Why Domestic Water Improvement District ("the District"), pursuant to A.R.S. § 48-1012, is required to hold an election to elect two members to the Board of Directors for those terms that expire December 31, 2028; and

WHEREAS, the number of candidates who filed nominating petitions pursuant to A.R.S. §16-311 or filed a write-in nomination paper pursuant to A.R.S. §16-312 was less than or equal to the number of positions that are up for election to the District Board of Directors at the November 5, 2024 General Election; and

WHEREAS, when only two people filed a nominating petition for election to a position on the District Board of Directors, the Pima County Board of Supervisors may pursuant to A.R.S. § 48-1012 (E), cancel the election and appoint the person(s) who filed; and

WHEREAS, Linda P. Hood and Amie Manuel are the only individuals to file nominating petitions or write-in nomination papers for election to fill the two open positions on the Board of Directors;

NOW, THEREFORE, upon motion duly made, seconded and carried, be it resolved as follows:

That the November 5, 2024 election for two positions on the Why Domestic Water Improvement District Board of Directors is cancelled and Linda P. Hood and Amie Manuel are appointed to serve on the Why Domestic Water Improvement District Board of Directors for a four year term beginning on January 1, 2025.
