Introduction/Background:

Acquisition of property for relocation of sewer facilities will be obtained by condemnation if needed.

RESOLUTION OF THE PIMA COUNTY BOARD OF SUPERVISORS AUTHORIZING THE PIMA COUNTY ATTORNEY TO CONDEMN REAL PROPERTY INTERESTS WHERE NECESSARY FOR THE NORTH RILLITO INTERCEPTOR IN SECTION 25 OF TOWNSHIP 13 SOUTH, RANGE 14 EAST AND SECTION 32 OF TOWNSHIP 13 SOUTH, RANGE 15 EAST, G&SRM

The Board of Supervisors of Pima County, Arizona finds:

- 1. Pima County plans to construct and maintain certain sewer improvements for the North Rillito Interceptor Project (the "Project") located in Section <u>25</u> of Township <u>13</u> South, Range <u>14</u> East and Section <u>32</u> of Township <u>13</u> South, Range <u>15</u> East, G&SRM, for the use and benefit of the public;
- 2. On September 1, 2015, the Board of Supervisors of Pima County enacted Resolution No. 2015-65, authorizing the Pima County Attorney to exercise its authority of eminent domain to acquire real property interests for the Project;
- 3. Two parcels from which property interests are necessary to the Project were erroneously excluded from the parcels depicted in Exhibit A attached to Resolution 2015-65;
- 4. The attached **Exhibit A** corrects the error by depicting all the parcels originally depicted in Exhibit A to Resolution 2015-65, as well as the two additional parcels; and
- 5. It is necessary to exercise Pima County's powers of eminent domain, pursuant to A.R.S. § 12-1111, to acquire interests in the real property depicted in attached **Exhibit A** in order to construct the Project;

NOW, THEREFORE, BE IT RESOLVED that the Pima County Attorney be and is hereby authorized and directed to institute condemnation proceedings to acquire real property interests for the above described Project, from the real property shown on the attached **Exhibit A**.

BE IT FURTHER RESOLVED that this Resolution repeals and replaces Resolution 2015-65.
