A RESOLUTION AND ORDER OF THE BOARD OF SUPERVISORS OF PIMA COUNTY, ARIZONA, PROVIDING FOR THE ESTABLISHMENT OF A SEGMENT OF ROAD RIGHT-OF-WAY ALONG MAGEEE ROAD NEAR THE INTERSECTION OF LA CHOLLA BLVD AS A COUNTY HIGHWAY SITUATED WITHIN A PORTION OF SECTION 33, TOWNSHIP 12 SOUTH, RANGE 13 EAST, GILA AND SALT RIVER MERIDIAN, PIMA COUNTY, ARIZONA.

UNDER PROCEEDING NO. 3017

WHEREAS, the County Engineer has requested that the Pima County Board of Supervisors establish a county highway commonly known as Magee Road and located in Section 33, Township 12 South, Range 13 East, Pima County, Arizona, pursuant to Arizona Revised Statutes (A.R.S.) Section 28-6701(B), said road being more fully described in attached Exhibit A, and

WHEREAS, the County Engineer filed a report and map of the proposed highway with the Board in accordance with A.R.S. § 28-6702(1), and

WHEREAS, said petition for establishment was set for a hearing before the Board on December 17, 2013, in accordance with A.R.S. § 28-6703, and

WHEREAS, notice of the hearing was published once a week for two consecutive weeks in a newspaper of general circulation prior to the hearing, and

WHEREAS, at the hearing on the 17th day of December, 2013, the Board considered the feasibility, advantages and necessity of the highway sought to be established and determined the

proposed highway to be a public necessity.

NOW, THEREFORE, IT IS HEREBY RESOLVED THAT:

1. The public roadway described in the attached Exhibit A and commonly referred to as

Magee Road is hereby established as a county highway.

2. The Clerk of the Board is hereby directed to record this Resolution and Order, together

with a map of said highway, as Establishment Proceeding No.3017 in the Office of the

Pima County Recorder, Pima County, Arizona.

3. The appropriate County officers and employees are hereby authorized and directed to

perform all acts necessary and desirable to give effect to this Resolution.

EXHIBIT "A" LEGAL DESCRIPTION ESTABLISHMENT PROCEEDINGS NUMBER 3017 MAGEE ROAD

A portion of Camino Del Sol Amended, a subdivision recorded in Book 33 of Maps and Plats at Page 78, together with portions of Lot 5 and Common Area "B" of Magee Center, a subdivision recorded in Book 56 of Maps and Plats at Page 94, recorded in the office of the County Recorder, Pima County, Arizona, and being within the northeast quarter of Section 33, Township 12 South, Range 13 East, Gila and Salt River Meridian, Pima County, Arizona more particularly described as follows:

COMMENCING at the northeast corner of said Section 33, to which the east quarter corner of said Section 33 bears South 00°38'37" East a distance of 2,641.74 feet;

THENCE along the east line of Section 33 South 00°38'37" East a distance of 1,320.66 feet;

THENCE South 89°21'23" West a distance of 75.00 feet to the west right of way line of La Cholla Boulevard and the **POINT OF BEGINNING**;

THENCE along said right of way line South 00°38'37" East a distance of 298.70 feet to the beginning of a tangent curve concave to the northwest having a radius of 25.00 feet and a central angle of 90°08'02";

THENCE along the arc of said curve to the right a distance of 39.33 feet to a point of tangency on the north right of way line of Magee Road;

THENCE along said north right of way line South 89°29'25"West a distance of 599.79 feet;

THENCE North 74°10'52" East a distance of 298.37 feet to the beginning of a non-tangent curve concave to the northwest and having a radius of 925.00 feet and a central angle of 19°53'12" to which a radial line bears South 24°18'43" East;


THENCE along the arc of said curve to the left a distance of 321.06 feet to a point of tangency;
