Pima County Victim Restitution Assistance Program

**\*Purpose:**

The purpose of the Pima County Victim Restitution Assistance Project (PC-VRAP) is to pilot a victim restitution assistance program for juvenile defendants in Pima County Juvenile Court (part of Arizona Superior Court in Pima County), who are unable to pay Court-ordered victim restitution. The inability to pay restitution is a significant barrier that inhibits juvenile clients' ability to resolve personal and environmental factors that increase their risk of recidivism. PC-VRAP will alleviate the financial burdens of indigent clients.

**\*Procurement Method:**

**\*Program Goals/Predicted Outcomes:**

Pima County projects that a juvenile restitution assistance program will show immediate impacts on case outcomes. Youth will be able to wrap up their court involvement more quickly; their families will be able to redirect their limited monetary resources to basic necessities and expenses that directly benefit their families; the youth will be eligible for destruction of records; and the victims will be made whole expeditiously. The predicted outcomes are hopefully to show that this program helps with recidivism rates in the juveniles who are part of this program.

**\*Public Benefit:**

The program benefits the public by allowing victim's to receive the restitution ordered by the Court. It will help juveniles and their families by resolving a financial burden that causes them to linger in the Justice System.

**\*Metrics Available to Measure Performance:**

No research is available regarding the use of either unpaid victim restitution, or restitution assistance, on juvenile violent crime or recidivism. However, among Public Defender juvenile attorneys there is a strong anecdotal consensus that the heavy burden of unpaid victim restitution hangs on clients for years and hampers their ability to engage in positive behaviors and implement life changes such as employment, education, counseling, or parenting activities. Unpaid restitution thwarts individuals' ability to resolve some of the personal and environmental factors that increase the risk of recidivism. Pima County Public Defense Services will be partnering with Tucson Second Change Community Bail Fund on this project. At present, there are no evidence-based practices to select or implement. Rather, through its pilot project, PDS hopes to collect, analyze, and evaluate sufficient data that will contribute to developing and defining promising practices related to the juvenile justice system's use of victim restitution orders and restitution payment assistance. A resource guide for juvenile justice system stakeholders, including judges, will be created to share learnings from the VRAP project implementation by the end of the fourth quarter following award. This grant deliverable will be updated annually thereafter. PDS will also be required to report to DOJ programmatically (semi-annually) and financially (quarterly).

**\*Retroactive:**

Yes, the performance period starts on October 1, 2022. The award notification was received on September 27, 2022. The next available Board of Supervisor's meeting is scheduled for October 18, 2022. If the Board opts not to accept the federal award, this vital program will not be implemented.

**Project Description**

Pima County Victim Restitution Assistance Program is a juvenile justice system enhancement designed to mitigate the financial burdens of indigent clients, including Black, Indigenous, and People of Color (BIPOC). The service area is Pima County, Arizona. The Public Defender's Juvenile Office (PDJV) within Pima County Public Defense Services (PDS), along with their sub-recipient, Tucson Second Chance Community Bail Fund (TSCCBF), will develop a pilot Victim Restitution Assistance Project for clients who have been unable to pay Court-ordered victim restitution.

The inability to pay restitution is a significant barrier that inhibits defendants' ability to resolve personal and environmental factors that increase the risk of recidivism. There is a lack of research on the impact of unpaid victim restitution (or restitution assistance) on juvenile violent crime or recidivism. Anecdotally, PDJV attorneys point to the years-long burden of unpaid restitution as a factor in recidivism. Unpaid restitution can lead to extended periods of Court involvement, the inability to destroy juvenile court records, and other collateral consequences. These consequences impair the youths' ability to obtain employment and sometimes housing, thereby fueling ongoing risk of delinquency and/or criminal involvement. This program will also assist in making victims whole and reducing the community impact of delinquent behavior.

The proposed Victim Restitution Assistance Program will consist of five components. They are 1) identification of qualified applicants in need of victim restitution assistance by their defense representation team and TSCCBF based on an eligibility rubric; 2) referral of applicants to TSCCBF, the payer; 3) evaluation by the TSCCBF; 4) payment of court-ordered victim restitution by the TSCCBF; and 5) data collection, evaluation and reporting. The desired outcomes are an increase in the number of individuals who are eligible for records destruction; increase in the number of victims receiving full payment of restitution, full resolution, restoration and reduced recidivism among recipients of assistance. The Juvenile Justice Systems Enhancement program will be reevaluated each year to determine program effectiveness for all participants and members of BIPOC communities. The evaluation will focus specifically on the number of cases that are resolved, the speed with which cases are resolved, the recidivism rate of the juveniles who are assisted by the program, and relevant socioeconomic factors. The Grant Manager and staff will work with the Technical Assistance Provider and Pima County Grant Research and Analysis unit to ascertain whether outcomes show the need for program adjustments throughout the grant period.

The recipient (and any subrecipient at any tier) must comply with, and is subject to, all applicable provisions of 41 U.S.C. 4712, including all applicable provisions that prohibit, under specified circumstances, discrimination against an employee as reprisal for the employee's disclosure of information related to gross mismanagement of a federal grant, a gross waste of federal funds, an abuse of authority relating to a federal grant, a substantial and specific danger to public health or safety, or a violation of law, rule, or regulation related to a federal grant.

Reg. 51225 (October 1, 2009), DOJ encourages recipients and subrecipients ("subgrantees") to adopt and enforce policies banning employees from text messaging while driving any vehicle during the course of performing work funded by this award, and to establish workplace safety policies and conduct education, awareness, and other outreach to decrease crashes caused by distracted drivers.
