



I am the mother of a student scheduled to enter first grade this year, and I am extremely concerned about the current status of COVID-19 in the Tucson Community. With positive COVID infection cases and hospitalizations soaring in spite of Tucson's vaccination rate, I have serious reservations about sending my daughter to school without assurance that all faculty, staff, and students will be wearing protective masks. Currently, our school district's policy is that masks are encouraged but they remain optional. I recognize that our Governor has signed an executive order banning mask mandates; however, I believe this order is unjust, potentially unenforceable, and far from reflective of our current public health crisis.

#### To the board of supervisors:

Last year, parents had several choices on what was best for their kids and situations with processes in place to protect those that were on campus. We had hybrid cohorts, mandatory masks, virtual classes, social distancing, strong cleaning/disinfectant processes, etc. all of which helped limit the number of people on campus and for those on campus helped limit the number of people they interacted with.

This year, campus opened fully. Which, for our school, meant over 900+ students in the building — most of which are not eligible for the vaccine. Walking on campus, my kids wore a mask, but unfortunately were in the minority of mask wearers.

As careful as my family is, my vaccinated husband got COVID. He got tested even though his symptoms were mild and could have been related to allergies or sinus infection because we wanted peace of mind. When they came back positive, we pulled our kids out of school even though they were not showing symptoms at the time because we did not want to chance them spreading Covid-19 to their peers. When my daughter started showing symptoms. We got her tested and they came back positive. We informed the school, and the school has been great at supporting us.

However, getting a covid test was not mandatory. Not every family is going to be extra cautious and get tested right away for mild symptoms. Not every family is going to pull their kid out of school right away. I'm hoping because my daughter was masked, it did limit the spread to others. However, contact tracing, active cases that are on the dashboard....those are only if I take the effort to get my family tested. If we chose to ride out the symptoms and self-quarantine, or just say the symptoms are anything but covid, those are not reported. Unless my kids are personally tested-the school is unable to take the additional steps needed at the school.

Wearing masks can protect our kids, but it can also protect our kids from unintentionally spreading the virus to others can prevent further spread.

can prevent further spread.

In short, follow the experts advice at the CDC. Implement mask mandates and while you are at it, bring back the options you offered last year to parents (virtual classes, cohorts, etc.)





Dear Pima County Board of Supervisors,

I am writing you as a concerned parent, community member and a Pediatrician. I am imploring you to mandate mask use at K-12 schools within Pima County. I am worried about the COVID-19 delta variant, increased risk of transmission and the children of Pima County. The CDC states the delta variant is as contagious as Varicella (Chickenpox). See the CDC slide below. New data from this week showed an average of **136 cases per day** in Pima County, a **41 percent increase** from the average two weeks ago[1]. This is not a political issue; it is basic science. We need to protect our children 11 and under who cannot be vaccinated. The best way to mitigate the risk of contracting COVID is social distancing, handwashing and the use of masks.

According to the American Academy of Pediatrics, almost 72,000 cases of COVID-19 were added the past week, a substantial increase from the prior week, when about 39,000 cases were reported. People will often argue that children have mild symptoms from COVID-19 but there are children that develop multisystem inflammatory system syndrome (MIS-C) and long-term symptoms due to COVID. We don't know what the

According to the American Academy of Pediatrics, almost 72,000 cases of COVID-19 were added the past week, a substantial increase from the prior week, when about 39,000 cases were reported. People will often argue that children have mild symptoms from COVID-19 but there are children that develop multisystem inflammatory system syndrome (MIS-C) and long-term symptoms due to COVID. We don't know what the full long-term effects of COVID-19 infection will be, but evidence is showing increased risk of stroke and decreased cognitive function among others. There have been over 400 pediatric deaths in the United States due to COVID-19. That is 400 families who do not have their child anymore. In person schools without mask mandates will put our children who cannot be vaccinated at greater risk than is needed. This will lead to outbreaks in schools and sick children. This will strain our health care systems and further stress a fatigued healthcare workforce.


Our public schools who serve a higher percentage of socially and economically disadvantaged children are being held to a different standard than private schools. Public schools now must make a choice to protect their students or incur legal fees. Many districts are paralyzed by the concern of "breaking the law" and are fearful of doing what is right to protect our children and community.



My name is Amelia Decker, MD and I am a pediatrician at Tanque Verde Pediatrics. Since the beginning of the start of the 2021-2022 school year for the Vail School District, our practice has been inundated with sick visits. A small but increasingly significant percentage of these are Covid positive. A large and significant percentage are visits related to other illnesses with responsible parents who are trying to rule out Covid to help contain spread. The children that we are seeing with Covid are sicker. The strain that these sick visits are putting on our office and on our patients' families cannot be understated.

We know that masks decrease the risk of transmission of Covid as well as other viruses. We know that in-person school continues to be the gold standard for our children. We know that vaccines decrease illness severity and Covid hospitalizations.

Please support a mask mandate for children in schools. Please support a mandatory vaccination policy for all teachers and staff of county schools. We cannot continue at this pace. For the first time we are seeing Pediatric Intensive Care Units with teen-age Covid patients. Our clinics are seeing 150 patients per day or more. These small interventions can make a large impact. I am writing as a community member and parent of two school-aged children in Pima County. I am gravely concerned about the plan to return to fully in-person learning with COVID safety protocols for the 2021-2022 school year that have changed from requiring masks for all students, teachers, and staff - as well as enhanced sanitation and physical distancing - to a policy where masks are "welcomed and encouraged." Current mitigation plans note that physical distancing will occur "where feasible'; however, it seems unlikely to be feasible with schools functioning at full capacity. These changes are not consistent with current CDC and American Academy of Pediatrics guidance. I fear that this will result in far fewer people wearing masks on campus and increase the risk of exposure to students, staff, and family members.

I am especially concerned that this change includes settings where students under the age of 12 learn. These children remain at great risk of contracting and spreading COVID because they are not currently eligible to receive the vaccine. This concern is amplified by the more infectious and aggressive Delta variant, which is the prominent strain found in Arizona and Pima County presently.

I believe that the health and safety of students, staff, and family members must remain paramount. Safety measures that enable students to learn as safely as possible in -person can and should be taken. What schools did last year with masking, remote-learning options, physical distancing, and so forth, worked - the current mitigation plan will only result in COVID outbreaks, school closures, reduced instructional time, increased mental illness, more COVID disease in the community, and increased mortality. I'm opposed to the mask mandate for K-12.

You are all in violation of our parental rights under ARS 1-601 and 1-602. Take a stand against child abuse!

#### ARS 8-201:

This establishes the legal definition of "abuse" in state law. It reads:

"Abuse" means the infliction or allowing of physical injury, IMPAIRMENT OF BODILY FUNCTION or disfigurement or the infliction of or allowing another person to CAUSE SERIOUS EMOTIONAL DAMAGE as evidenced by severe anxiety, depression, withdrawal or untoward aggressive behavior and which emotional damage is diagnosed by a medical doctor or psychologist and is caused by the acts or omissions of an individual who has the care, custody and control of a child.

School districts across Arizona are being permitted to violate state statute and abuse our children with impunity.

Unlike violations of the parents rights statutes, there are real and serious consequences for committing the crime of child abuse.

#### ARS 13-3623:

Under circumstances other than those likely to produce death or serious physical injury to a child, any person who causes a child to suffer physical injury or ABUSE or, having the care or custody of a child, who causes or permits the person or health of the child to be injured or who causes or permits a child to be placed in a situation where the person or health of the child is endangered is guilty of an offense as follows:

- 1. If done intentionally or knowingly, the offense is a class 4 felony.
- 2. If done recklessly, the offense is a class 5 felony.
- 3. If done with criminal negligence, the offense is a class 6 felony.

It goes on to state that, "Abuse", when used in reference to a child, means abuse as defined in section 8-201.

FYI: BREATHING IS A CRITICAL BODILY FUNCTION AND MASKS COVERING THE NOSE AND MOUTH IMPAIRS IT!!

Officials in our state have turned a blind eye to this and allowed our children to literally be abused in the name of "protecting others." We cannot continue to allow children to be sacrificed to provide a false sense of security to adults that refuse to accept scientific data and evidence. A. Notwithstanding any other law or order, a county, city, town, school district governing board or charter school governing body may NOT require the use of face coverings by students or staff during school hours and on school property.

B. A school district or charter school may NOT require a student or teacher to receive a vaccine for Covid-19 or to wear a face covering to participate in in-person instruction.

Section 117. Retroactivity

A. Section 15-342.05, Arizona Revised Statutes, as added by this act, applies retroactively to from and after June 30, 2021.



I am communicating with you today in regards to the health and safety of the students in our district. My son is in grade at Ironwood Elementary. I am a high-risk single parent, and I am terrified. äĔ

As we know COVID is still present in our community, in fact, a new variant is now present that is 5 to 8 times as contagious as the original variant. Moreover, it is more dangerous to kids, Currently over 19,000 children are becoming infected with COVID every day in the US. So far, more than 32 children in Arizona have died. Our state has second most child deaths in the country - even more than Texas, which has 29 million people versus our 7.2 million people. How many more children need to die in our state before we take action?

We also know that vaccines and masks work. They are part of a multi-level mitigation plan along with social distancing and other measures that are proven to work. This is why I want to strongly encourage you to do the right thing and require masks in your schools and classrooms. Masking is the recommended approach to keep children safe. It is our best option right now. It is strongly recommended by numerous health professionals and experts at the international (e.g., World Health Organization), the national (e.g., the American Academy of Pediatrics) and the state level (e.g., the Arizona Medical Association).

Thank you for your time and service to Pima County, I sincerely appreciate it.



To Whom It May Concern,

I'm opposed to the mask mandate for K-12. I ask that you review my attached documents and that you remove the masks from all schools. You are all in violation of our parental rights under ARS 1-601 and 1-602.

Take a stand against child abuse.

ARS 8-201, establishes the legal definition of "abuse" in state law. It reads;

"Abuse" means the infliction or allowing of physical injury, IMPAIRMENT OF BODILY FUNCTION or disfigurement or the infliction of or allowing another person to CAUSE SERIOUS EMOTIONAL DAMAGE as evidenced by severe anxiety, depression, withdrawal or untoward aggressive behavior and which emotional damage is diagnosed by a medical doctor or psychologist and is caused by the acts or omissions of an individual who has the care, custody and control of a child.

School districts across Arizona are being permitted to violate state statute and abuse our children with impunity.

Unlike violations of the parents rights statutes, there are real and serious consequences for committing the crime of child abuse ARS 13-3623

Under circumstances other than those likely to produce death or serious physical injury to a child, any person who causes a child to suffer physical injury or ABUSE or, having the care or custody of a child, who causes or permits the person or health of the child to be injured or who causes or permits a child to be placed in a situation where the person or health of the child is endangered is quilty of an offense as follows: endangered is guilty of an offense as follows:

- 1. If done intentionally or knowingly, the offense is a class 4 felony.
- 2. If done recklessly, the offense is a class 5 felony.
- 3. If done with criminal negligence, the offense is a class 6 felony.

#### It goes on to state that,

"Abuse", when used in reference to a child, means abuse as defined in section 8-201.

#### FYI: BREATHING IS A BODILY FUNCTION AND MASKS COVERING THE NOSE AND MOUTH IMPAIRS IT

Officials in our state have turned a blind eve to this and allowed our children to literally be abused in the name of "protecting others." We cannot continue to allow children to be sacrificed to provide a false sense of security to adults that refuse to accept scientific data and evidence. To Whom It May Concern:

I am sending you this notice, on behalf of Joshua Hinyup. My findings raise significant concerns, both medically and legally, of the current mask policy in place. Masks are ineffective for the purpose claimed by the mandate, potentially harmful, and only authorized for use by an EUA.

#### Masks are ineffective and in many ways they harm.

It's a myth that masks prevent viruses from spreading. The overall evidence is clear: Standard cloth and surgical masks offer next to no protection against virus-sized particles or small aerosols. The size of a virus particle is much too small to be stopped by a surgical mask, cloth or bandana. A single virion of SARS-CoV-2 is about 60-140 nanometers or 0.1 microns. The pore size in a surgical mask is 200-1000x that size. Consider that the CDC website states, "surgical masks do not catch all harmful particles in smoke." And that the size of smoke particles in a wildfire are ~0.5 microns which is 5x the size of the SARS-CoV-2 virus! Wearing a mask to prevent catching SARS-CoV-2, or similarly sized influenza, is like throwing sand at a chain-link fence: it doesn't work. There has been one large randomized controlled trial that specifically examined whether masks protect their wearers from the coronavirus. This study found mask wearing "did not reduce, at conventional levels of statistical significance, the incidence of Sars-Cov-2-infection."

Consider also, that the existence of more particles does not mean more virus. Research shows less virus does not mean less illness. Dr. Kevin Fennelly, a pulmonologist at the National Heart, Lung and Blood institute debunked the view that larger droplets are responsible for viral transmission. Fennelly wrote:

"current infection control policies are based on the premise that most respiratory infections are transmitted by large respiratory droplets- i.e., larger than 5 [microns] — produced by coughing and sneezing, ... Unfortunately, that premise is wrong."

Fennelly referenced a 1953 paper on anthrax that showed a single bacterial spore of about one micron was significantly more lethal than larger clumps of spores.<sup>5</sup> Exposure to one virus particle is theoretically enough to cause infection and subsequent disease. This is not an alarming thought - it simply means what it has always meant, that our immune system protects us continually all our life.<sup>6</sup>

There have been hundreds of mask studies related to influenza transmission done over several decades. It is a well-established fact that masks do not stop viruses. "Part of that evidence shows that cloth facemasks actually increase influenza-linked illness." Bacteria are 50x larger than virus particles. As such, virus particles can enter through the mask pores, yet bacteria remain trapped inside of the mask, resulting in the mask-wearer continually exposed to the bacteria.

Related to the 1918-1919 influenza pandemic, there was almost universal agreement among experts, that deaths were virtually never caused by the influenza virus itself but resulted directly from severe secondary pneumonia caused by well-known bacterial "pneumopathogens" that colonized the upper respiratory tract.<sup>9</sup> Dr. Fauci and his National Institute of Health studied pandemics and epidemics and concluded, "the vast majority of influenza deaths resulted from secondary bacterial pneumonia." <sup>10</sup>

All parties mandating the use of facemasks are not only willfully ignoring established science but are engaging in what amounts to a whole school clinical experimental trial. This conclusion is reached by the fact that facemask use and COVID-19 incidence are being reported in scientific opinion pieces promoted by the CDC and others. The fact is after reviewing ALL of the studies worldwide, the CDC found "no reduction in viral transmission with the use of face masks."

Additionally, Children have been repeatedly shown not to be drivers of this contagion. It is well-accepted that children have a statistically zero chance of dying from COVID. The CDC shows the K-12 mortality rate from or with COVID is .00003. Any intervention, especially one that is prophylactic, must cause fewer harms to the recipient than the infection. Since children have the lowest death rate from COVID infection, the cost-benefit of requiring children to wear an investigational face-covering with emerging safety issues is especially difficult to justify. Anthony Fauci was very clear that asymptomatic transmission was not a threat. He stated, "in all the history of respiratory-borne viruses of any type, asymptomatic transmission has never been the driver of outbreaks. The driver of outbreaks is always a symptomatic person." 14

Wearing respirators come(s) with a host of physiological and psychological burdens. These can interfere with task performances and reduce work efficiency. These burdens can even be severe enough to cause life-threatening conditions if not ameliorated.<sup>15</sup> Fifteen years ago, National Taiwan University Hospital concluded that the use of N-95 masks in healthcare workers caused them to experience hypoxemia, a low level of oxygen in the blood, and hypercapnia, an elevation in the blood's carbon dioxide levels.<sup>16</sup> Studies of simple surgical masks found significant reductions in blood oxygen as well. In one particular study, researchers measured blood oxygenation before and after surgeries in 53 surgeons. Researchers found the mask reduced the blood oxygen levels significantly, and the longer the duration of wearing the mask, the greater the drop in blood oxygen levels.<sup>17</sup>

Moreover, people with cancer, will be at a further risk from hypoxia, as cancer cells grow best in a bodily environment that is low in oxygen. Low oxygen also promotes systemic inflammation which, in turn, promotes "the growth, invasion and spread of cancers." Repeated episodes of low oxygen, known as intermittent hypoxia, also "causes atherosclerosis" and hence increases "all cardiovascular events" such as heart attacks, as well as adverse cerebral events like stroke. <sup>19</sup>

Furthermore, the mandatory mouth mask in schools is a major threat to a child's development. It ignores the essential needs of a growing child. The well-being of children and young people is highly dependent on the emotional connection with others. Masks create a threatening and unsafe environment, where emotional connection becomes difficult.<sup>20</sup>


#### Informed consent is required for investigational medical therapies.

Regardless of the lack of safety and efficacy behind the decision to require a child to wear a mask, it is illegal to mandate EUA approved investigational medical therapies without informed consent. Mask use for viral transmission prevention is authorized for Emergency Use only. Emergency Use Authorization by the FDA, means "the products are investigational and experimental" only. The statute granting the FDA the power to authorize a medical product of emergency use requires that the person being administered the unapproved product be advised of his or her right to refuse administration of the product. This statute further recognizes the well-settled doctrine that medical experiments, or "clinical research," may not be performed on human subjects without the express, informed consent of the individual receiving treatment.

The right to avoid the imposition of human experimentation is fundamental, rooted in the Nuremberg Code of 1947, has been ratified by the 1964 Declaration of Helsinki, and further codified in the United States Code of Federal Regulations. In addition to the Unites States regarding itself as bound by these provisions, these principles were adopted by the FDA in its regulations requiring the informed consent of human subjects for medical research.<sup>25</sup> Arizona. The law is very clear; It is unlawful to conduct medical research (even in the case of emergency), unless steps taken to ... secure informed consent of all participants.<sup>26</sup>

Furthermore, by requiring children to wear a mask, you are promoting the idea that the mask can prevent or treat a disease, which is an illegal deceptive practice. It is unlawful to advertise that a product or service can prevent...disease unless you possess competent and reliable scientific evidence... substantiating that the claims are true.<sup>27</sup>

The FDA EUA for surgical and/or cloth masks explicitly states, "the labeling must not state or imply... that the [mask] is intended for antimicrobial or antiviral protection or related, or for use such as infection prevention or reduction."<sup>28</sup> As you can see from the image below, masks do not claim to keep out viruses.



Illegally mandating an investigational medical therapy generates liability.

There are no efficacy standards on child-sized masks and respirators under OSHA, but there are proven microbial challenges as well as breathing difficulties that are created and exacerbated by masking children.

Requiring children to wear a mask sets the stage for contracting any infection, including COVID-19, and making the consequences of that infection much graver. In essence, a mask may very well put children at an increased risk of infection, and if so, having a far worse outcome.<sup>29</sup>

The fact that mask wearing presents a severe risk of harm to the wearer should – standing alone – not be required for children, particularly given that these children are not ill and have done nothing wrong that would warrant an infringement of their constitutional rights and bodily autonomy. Promoting use of a non-FDA approved, Emergency Use Authorized mask, is unwarranted and illegal. This mandate is in direct conflict with Section 360bbb-3£(1)(A)(ii)(I-III), which requires the wearer to be informed of the option to refuse the wearing of such "device." Misrepresenting the use of a mask as being intended for antimicrobial or antiviral protection, and/or misrepresenting masks for use as infection prevention or reduction is a deceptive practice under the FTC. It is clear, there is no waiver of liability under deceptive practices, even under a state of emergency. As such, forcing children to wear masks, or similarly forcing use any other non-FDA approved medical product without the child's (or the child's parental) consent, is illegal and immoral.

This letter serves as official notice that does not consent to being forced to wear a mask. Advocates will not fail to take the maximum action permissible under the law against your organization, and against you personally. Accordingly, I urge you to comply with Federal and State law, and advise children they have a right to refuse or wear a mask as a measure to prevent or reduce infection from COVID-19. Any other course of action is contrary to the law. I am willing to testify as to the veracity of the contents in this document. Please confirm no further pressure will be exerted upon to follow this illegal mask mandate, and that will not face any retaliatory disciplinary action.

# Arizona Department of Education Office of Kathy Hoffman Superintendent of Public Instruction

### Arizona Department of Education Parental Rights Handbook Public Charter Schools

Last Updated: September 10, 2020

#### Background

In the 2020 Arizona Legislative Session, the Legislature passed Senate Bill (SB) 1061 (<u>Laws 2020</u>, <u>Chapter 64</u>) which the Governor signed on June 5, 2020. SB 1061 established ARS § 15-249.16 which requires the Arizona Department of Education (Department) to establish and post a statutory handbook of parental rights. Additionally, each school district and charter school must prominently post a link to the statutory handbook of parental rights on a publicly accessible portion of their website. Per <u>A.R.S. § 15-249.16</u>, the handbook of parental rights for parents and families of public charter schools must contain the following statutes:

- Title 1, Chapter 6
  - o <u>Section 1-601</u>
  - o Section 1-602
- Title 15, Chapter 1
  - o Section 15-110
  - Section 15-113
  - o Section 15-117

This document contains the required statutes per SB 1061 and fulfills the Department's role in developing and posting the parental rights handbook pursuant to A.R.S. § 15-249.16. In addition to posting on the Department's website, this document will be distributed to each public school for posting.

#### **Statutory Language**

#### A.R.S. § 1-601 – Parents' rights protected

A. The liberty of parents to direct the upbringing, education, health care and mental health of their children is a fundamental right.

B. This state, any political subdivision of this state or any other governmental entity shall not infringe on these rights without demonstrating that the compelling governmental interest as applied to the child involved is of the highest order, is narrowly tailored and is not otherwise served by a less restrictive means.

#### A.R.S. § 1-602 - Parents' bill of rights; definition

- A. All parental rights are reserved to a parent of a minor child without obstruction or interference from this state, any political subdivision of this state, any other governmental entity or any other institution, including:
  - 1. The right to direct the education of the minor child.
  - 2. All rights of parents identified in title 15, including the right to access and review all records relating to the minor child.
  - 3. The right to direct the upbringing of the minor child.
  - 4. The right to direct the moral or religious training of the minor child.
  - 5. The right to make health care decisions for the minor child, including rights pursuant to sections 15-873, 36-2271 and 36-2272, unless otherwise prohibited by law.
  - 6. The right to access and review all medical records of the minor child unless otherwise prohibited by law or the parent is the subject of an investigation of a crime committed against the minor child and a law enforcement official requests that the information not be released.
  - 7. The right to consent in writing before a biometric scan of the minor child is made pursuant to section 15-109.
  - 8. The right to consent in writing before any record of the minor child's blood or deoxyribonucleic acid is created, stored or shared, except as required by section 36-694, or before any genetic testing is conducted on the minor child pursuant to section 12-2803 unless authorized pursuant to section 13-610 or a court order.
  - 9. The right to consent in writing before the state or any of its political subdivisions makes a video or voice recording of the minor child, unless the video or voice recording is made during or as a part of a court proceeding, by law enforcement officers during or as part of a law enforcement investigation, during or as part of an interview in a criminal or child safety services investigation or to be used solely for any of the following:
    - (a) Safety demonstrations, including the maintenance of order and discipline in the common areas of a school or on pupil transportation vehicles.
    - (b) A purpose related to a legitimate academic or extracurricular activity.
    - (c) A purpose related to regular classroom instruction.
    - (d) Security or surveillance of buildings or grounds.
    - (e) A photo identification card.

- 10. The right to be notified promptly if an employee of this state, any political subdivision of this state, any other governmental entity or any other institution suspects that a criminal offense has been committed against the minor child by someone other than a parent, unless the incident has first been reported to law enforcement and notification of the parent would impede a law enforcement or child safety services investigation. This paragraph does not create any new obligation for school districts and charter schools to report misconduct between students at school, such as fighting or aggressive play, that is routinely addressed as a student disciplinary matter by the school.
- 11. The right to obtain information about a child safety services investigation involving the parent pursuant to section 8-807.
- B. This section does not authorize or allow a parent to engage in conduct that is unlawful or to abuse or neglect a child in violation of the laws of this state. This section does not prohibit courts, law enforcement officers or employees of a government agency responsible for child welfare from acting in their official capacity within the scope of their authority. This section does not prohibit a court from issuing an order that is otherwise permitted by law.
- C. Any attempt to encourage or coerce a minor child to withhold information from the child's parent shall be grounds for discipline of an employee of this state, any political subdivision of this state or any other governmental entity, except for law enforcement personnel.
- D. Unless those rights have been legally waived or legally terminated, parents have inalienable rights that are more comprehensive than those listed in this section. This chapter does not prescribe all rights of parents. Unless otherwise required by law, the rights of parents of minor children shall not be limited or denied.
- E. For the purposes of this section, "parent" means the natural or adoptive parent or legal guardian of a minor child.

### A.R.S. § 15-110 – Rights of students at public educational institutions; limitations; definition

- A. A public educational institution shall not discriminate against students or parents on the basis of a religious viewpoint or religious expression.
- B. If an assignment requires a student's viewpoint to be expressed in coursework, artwork or other written or oral assignments, a public educational institution shall not penalize or reward a student on the basis of religious content or a religious viewpoint. In such an assignment, a student's academic work that expresses a religious viewpoint shall be evaluated based on ordinary academic standards of substance and relevance to the course curriculum or requirements of the coursework or assignment.
- C. Students in public educational institutions may pray or engage in religious activities or religious expression before, during and after the school day in the same manner and to the same extent that students may engage in nonreligious activities or expression.

- D. Students in public educational institutions may wear clothing, accessories and jewelry that display religious messages or religious symbols in the same manner and to the same extent that other types of clothing, accessories and jewelry that display messages or symbols are permitted.
- E. This section shall not be construed to authorize this state or any of its political subdivisions to do either of the following:
  - 1. Require any person to participate in prayer or in any other religious activity.
  - 2. Violate the constitutional rights of any person.
- F. This section shall not be construed to limit the authority of any public educational institution to do any of the following:
  - 1. Maintain order and discipline on the campus of the public educational institution in a content and viewpoint neutral manner.
  - 2. Protect the safety of students, employees and visitors of the public educational institution.
  - 3. Adopt and enforce policies and procedures regarding student speech at school provided that the policies and procedures do not violate the rights of students as guaranteed by the United States and Arizona constitutions and laws.
  - 4. Adopt and enforce policies and procedures that prohibit students from wearing any type of clothing, accessories and jewelry that is worn with the intent to convey affiliation with a criminal street gang as defined in section 13-105.
- G. A student or a student's parent shall not initiate legal action to enforce this section unless the student or the student's parent has done the following:
  - 1. The student or the student's parent shall submit a complaint in writing with the specific facts of the alleged violation to the principal of the school. The principal shall investigate the complaint and respond in writing, including a description of any action taken to resolve the complaint, within fifteen days of receiving the written complaint.
  - 2. If the action taken by the principal of the school does not resolve the complaint of the student or the student's parent, the student or the student's parent shall submit a complaint in writing with the specific facts of the alleged violation to the superintendent or designated administrator. The superintendent or designated administrator shall investigate the complaint and respond in writing, including a description of any action taken to resolve the complaint, within twenty-five days of receiving the written complaint.
  - 3. If the action taken by the superintendent or designated administrator does not resolve the complaint of the student or the student's parent, the student or the student's parent may pursue legal action to enforce this section.

- H. For the purposes of this section, "public educational institution" means any of the following:
  - 1. A school district, including its schools.
  - 2. A charter school.
  - An accommodation school.
  - 4. The Arizona state schools for the deaf and the blind.

#### A.R.S. § 15-113 - Rights of parents; public educational institutions; definitions

- A. A parent of a student in a public educational institution has the right to review learning materials and activities in advance. A parent who objects to any learning material or activity on the basis that the material or activity is harmful may request to withdraw that student from the activity or from the class or program in which the material is used and request an alternative assignment.
- B. A charter school may require parents to waive the right to object to learning materials or activities pursuant to subsection A as a condition of enrollment if the charter school provides a complete list of books and materials to be used each school year before the student enrolls. If the charter school introduces books or materials that were not disclosed prior to enrollment, the parent retains the right to object to those materials pursuant to subsection A.
- C. A charter school may require that any request to review learning materials or activities or to withdraw the student from learning materials or activities pursuant to subsection A be made in writing.
- D. A public educational institution shall obtain signed, written consent from a student's parent or guardian before using video, audio or electronic materials that may be inappropriate for the age of the student.
- E. For the purposes of this section:
  - 1. "Objects to any learning material or activity on the basis that it is harmful" means objections to a material or activity because of sexual content, violent content, or profane or vulgar language.
  - 2. "Public educational institution" means any of the following:
    - (a) A school district, including its schools.
    - (b) A charter school.
    - (c) An accommodation school.
    - (d) The Arizona state schools for the deaf and the blind.

## A.R.S. § 15-117 – Surveys; pupil information; parental permission and informed consent; exceptions; penalties; definitions

A. Notwithstanding any other law, each school district and charter school shall obtain written informed consent from the parent of a pupil before administering any survey that is retained by a school district, a charter school or the department of education for longer than one year and that solicits personal information about the pupil regarding any of the following:

- 1. Critical appraisals of another person with whom a pupil has a close relationship.
- 2. Gun or ammunition ownership.
- 3. Illegal, antisocial or self-incriminating behavior.
- 4. Income or other financial information.
- 5. Legally recognized privileged or analogous relationships, such as relationships with a lawyer, physician or member of the clergy.
- 6. Medical history or medical information.
- 7. Mental health history or mental health information.
- 8. Political affiliations, opinions or beliefs.
- 9. Pupil biometric information.
- 10. The quality of home interpersonal relationships.
- 11. Religious practices, affiliations or beliefs.
- 12. Self-sufficiency as it pertains to emergency, disaster and essential services interruption planning.
- 13. Sexual behavior or attitudes.
- 14. Voting history.
- B. At the beginning of every school year, every school district and charter school shall obtain written informed consent from the parent of a pupil to participate in any survey pursuant to subsection A of this section for the entire year. A parent of a pupil may at any time revoke consent for the pupil to participate in any survey pursuant to subsection A of this section. For any pupil who is at least eighteen years of age, the permission or consent that would otherwise be required from the pupil's parent pursuant to this section is required only from the pupil. All surveys conducted pursuant to subsection A of this section shall be approved and authorized by the school district or charter school is subject to the penalties prescribed in subsection L of this section. A teacher or other school employee may not administer

any survey pursuant to subsection A of this section without written authorization from the school district or charter school.

- C. This section applies to all surveys conducted pursuant to subsection A of this section:
  - 1. Regardless of the stated purpose of the survey.
  - 2. Regardless of the quantity or percentage of questions that solicit data pursuant to subsection A of this section.
  - 3. Including written or digital surveys.
- D. This section does not apply to:
  - 1. Mental health screening pursuant to section 15-104 or the identification of or programming for children with disabilities or gifted pupils pursuant to chapter 7, articles 4 and 4.1 of this title.
  - 2. Class instruction, discussion or assignments on subjects within the purview of the course.
  - 3. Private schools.
  - 4. Any nationally recognized college entrance exam that a student chooses to take regardless if the administration of the exam takes place on public school property.
  - 5. Any survey conducted that contains questions soliciting information pursuant to subsection A of this section if the survey does not require a student's name or any other personally identifiable information.
  - 6. Any survey conducted or implemented by the Arizona criminal justice commission.
  - 7. Any method of surveying a student that is conducted because a person has a reasonable belief that a minor is or has been a victim of abuse pursuant to section 13-3620.
- E. A penalty may not be imposed on a pupil or the parent of a pupil who does not participate in any survey conducted pursuant to subsection A of this section. Participation in any survey pursuant to subsection A of this section is not required:
  - 1. To demonstrate that a pupil has met competency requirements for any grade level, course or subject.
  - 2. For a pupil to qualify for placement into any grade level, course or subject.
  - 3. For a pupil to be promoted to the next grade.

- 4. For a pupil to receive credit for any course or as part of a letter grade for any course.
- 5. For a pupil to graduate from high school.
- 6. For a pupil to obtain a high school equivalency diploma.
- F. A school district or charter school shall provide an alternative educational activity for any pupil whose parent does not consent for that pupil to participate in a survey conducted pursuant to subsection A of this section.
- G. Any pupil whose parent does not give written informed consent for that pupil to participate in any survey pursuant to subsection A of this section and who attends the alternative educational activity pursuant to this section shall be counted toward daily attendance and average daily membership for the school pursuant to section 15-901 and may not be counted absent from school.
- H. Responses to any survey pursuant to subsection A of this section may not be included:
  - 1. As part of a school academic performance indicator pursuant to section 15-241, or as part of any other similar school rating system.
  - 2. In the education learning and accountability system pursuant to section 15-249, or in any other similar system.
  - 3. In the student accountability information system pursuant to section 15-756.10 or 15-1041, or in any other similar system.
- I. A penalty may not be imposed on and a reward may not be granted to a teacher, administrator, other school employee, school district, school or charter school based on the pupil participation rate in any survey conducted pursuant to subsection A of this section.
- J. On request, a charter school or school district shall provide any available information in a timely manner to the parent of a pupil regarding a survey administered pursuant to subsection A of this section including:
  - 1. The name of the survey.
  - 2. The date or dates on which the survey will be administered.
  - 3. The method or methods of administering the survey.
  - 4. The amount of time required to administer the survey.
  - 5. The type of information collected by the survey.
  - 6. The reasons for administering the survey.

- K. A parent of a pupil that has a reasonable belief that a school district or charter school has violated this section may file a complaint with the attorney general or the county attorney for the county in which an alleged violation of this section occurred. The attorney general or the county attorney for the county in which an alleged violation of this section occurred may initiate a suit in the superior court in the county in which the school district or charter school is located for the purpose of complying with this section. After receiving written notice of an alleged failure to comply with this section, a school district or charter school that determines that a violation has occurred is not subject to a penalty or cause of action under this section if the school district or charter school cures the violation. For the purposes of this subsection, "cure" means to destroy any information gathered in violation of this section and to provide written instruction to the individual circulating the survey, to be kept on file for one year after receipt of the written notice of the alleged failure to comply.
- L. For each violation of this section, the court may impose a civil penalty not to exceed five hundred dollars. The school district or charter school determined to be out of compliance with this section shall be responsible for the payment of all penalties.
- M. An attorney acting on behalf of a public school may request a legal opinion of the county attorney or attorney general as to whether the public school would violate this section.
- N. All penalties collected by the court for a suit initiated in superior court by the attorney general shall be paid to the office of the attorney general for the use and reimbursement of costs of prosecution pursuant to this section. All penalties collected by the court for a suit initiated in superior court by a county attorney shall be paid to the county treasurer of the county in which the court is held for the use and reimbursement of costs of prosecution pursuant to this section.
- O. For the purposes of this section:
  - 1. "Parent" has the same meaning prescribed in section 15-101, except that parent does not mean this state if the pupil is a ward of the state.
  - 2. "Survey" means:
    - (a) When used as a noun, an instrument that investigates the attitudes, behaviors, beliefs, experiences, opinions or thoughts of a pupil or group of pupils.
    - (b) When used as a verb, to use an instrument to investigate the attitudes, behaviors, beliefs, experiences, opinions or thoughts of a pupil or group of pupils.
