AMENDMENT #3

This amends the above described agreement dated May 4, 2010 by and between the PIMA COUNTY BOARD OF SUPERVISORS ("BOARD") and the PIMA COUNTY SCHOOL SUPERINTENDENT ("SUPERINTENDENT") for the use of election services to conduct special school district elections.

1. BACKGROUND.

- 1.1 <u>Agreement.</u> The Pima County Board of Supervisors ("Board") and the Pima County School Superintendent ("Superintendent") entered into an Agreement on May 4, 2010, for the use of election services to conduct special school district elections.
- 1.2 <u>Term of Agreement</u>. The term of the Agreement began on July 1, 2010, and continued through June 30, 2011. The Agreement was amended on June 19, 2012 to extend it through June 30, 2013. The Agreement may be extended for one (1) year terms upon written agreement of the parties.
- 2. **MODIFICATION OF AGREEMENT**. The Superintendent wishes to extend the Agreement with the Board by one (1) year with a new end date of June 30, 2014.
- 3. **REMAINING AGREEMENT TERMS UNCHANGED**. Except as modified as provided in this Amendment, all of the terms and conditions of the Agreement shall remain in full force and effect.
- 4. **EFFECTIVE DATE.** This Amendment shall be effective as of the date this Amendment is executed by all of the parties hereto.
