Greetings,

Vote NO on agenda items 26, 27, and 54 regarding renewals of existing or new 5G contracts. Did you check with the residents located near these properties? Did you conduct NEPA studies?

Specifically VOTE NO on Item #54: Hearing - Type III Conditional Use Permit for a new wireless communication facility (Parcel Code 209-29-032A) ... located on the south side W. Vegas Drive near the intersection of W. Vegas Drive and S. Alice Vail Lane, addressed as 12025 W. Vegas Drive.

You've agreed to serve us as trustees to work on our behalf and for the benefit of the people, When you were sworn your oath of office. Please protect the people from invasive and dangerous electromagnetic frequency pollution. Reminder, you've allowed some of the 500 plus 3-5G towers and small wireless facilities. It would be to your benefit if you did not approve any more 5G towers or small wireless facilities. Especially, after you were made aware of the dangers to people's safety, to the loss of property values of more than 20% and the dangers to children at home and in schools.

More than 1,500 people provided you and the city council with letters. More than 500 notarized affidavits were mailed in to alert you and the city council. Are you so callous as to endanger all of us? Your family, friends, and neighbors will also be negatively impacted 24 hours a day, seven days a week, 365 days a year, for many years. Once a large population explodes with unexplained health problems, the damage is done.

Reminder, studies conducted more than 15 years ago have found that exposure to wireless utility meters, small wireless facilities and the growing forest of transmitting poles of various generations of pulsed energy. Everyone's health, safety and property values are impacted including City Councils, Pima County supervisors, all Schools, churches, and businesses. We have a simple solution, fiberoptic in the ground. In the 1990's Pima County residents paid for fiber optics in the ground. We'd like to get this knowledge to the public before

there's too much irreversible damage.

My grievance is the systematic neglect since and your unwillingness to meet with us or Andrew Campanelli. He's an environmental lawyer who helps write protective ordinances and gives sound advice how to mitigate this public nuisance per HUD and ADA. I assert, that everyone in the county and the City will be impacted regarding safety, health and loss of home values (-20%). Most people are not educated about it. I love technology and want everyone to be safe in their own homes. Do you wonder why there's a rise in Alzheimer's, Dementia, brain tumors, cancers, MS, ALS, Parkinson, etc? This is an invisible and silent threat to our wellbeing at the cellular level, including animals and nature.

Fountain Hill listened to our public comments, and they've secured a protective ordinance prior to 5G pole deployment. Prescott is also following their lead. Pima County and City of Tucson, however, have allowed more than 520 plus cell towers and small wireless transfer facilities (SWTFs) since February 2021.

We will not know the impact of many years of exposure. There's a proliferation of Alzheimer's, Dementia, Parkinson's and various cancers. Glioblastoma, brain cancer is on the rise. It is attributed to cell phone and wireless device use. Why not rather err on the side of caution? I ask you not to approve any more cellular towers. Please vote no.

To paraphrase the National League of Cities, the National Association of Counties, US Conference of Mayors, and National Association of Telecommunications Officers and Advisors'; the protection of local government of its citizens are critical to conduct responsible stewardship of public property, protect public safety, and preserve the rights of residents as consumers of broadband services and neighbors to the infrastructure that makes connectivity possible. Unintended consequence of a thoughtless process without any environmental studies, or input of the citizens that are directly affected, could impose high costs on a County and a City, burdens on taxpayers, interference with public safety and harm protections that are the heart of localism without substantively improving broadband deployment.
