The Assessor's review indicated that the organization filed their affidavit in a timely manner for 2022, but at that time provided incorrect information which is why they were denied. The correct information has been provided with this petition, and if the Assessor would have had the corrected information at that time, Parcel No. 123-07-101A would have been granted 100% exemption and Parcel No. 123-07-104A would have been granted 99% exemption due to a portion being rented which was acknowledged by the organization.

The Asessor's review also indicated that their 2023 filing corrected the information and was approved for 2023.

Our Saviour's is a member in good standing of the larger Evangelical Lutheran Church in America and is part of the Grand Canyon Synod.

Our Saviour's Lutheran Church was founded in 1945 and is the oldest Evangelical Lutheran Church in Tucson. Our vision is to be a loving, inclusive, and inviting community in Christ. To bring our vision into reality we develop our faith through worship and the study of God's Word.

Since our founding, the entirety of properties that make up the church campus have been used to support that vision and are used exclusively for religious, educational and charitable purposes. Worship services are conducted in our main Sanctuary weekly on Sundays and on other special occasions. Weekly prayer services are held in our Chapel. Our meeting spaces are used by church members for Christian education, Bible Study, Youth Faith Development, Mindfulness Meditation, and numerous other religious and spiritually based activities.

Church offices and meeting spaces are used by the staff and by various committees necessary to conduct the business and running of the Church. In addition, space is used for meetings by other outside groups consistent with our beliefs in providing a safe and welcoming space for healing, and connection to the larger community such as AA, Nar-Anon and Tucson Interfaith HIV/AIDS Network (TIHAN).

A separate space on our campus is used by Lutheran Campus Ministries, an outreach to students at the University of Arizona. It offers a community of Worship, fellowship, and community service opportunities to students of any faith.

This petition before the Board of Supervisors is for relief of property taxes for Our Saviour's Evangelical Lutheran Church located at 1200 North Campbell Avenue, Tucson, Arizona 85719-4608, phone: 520-327-6521, email: oslc@lutherantucson.org, website: www.lutherantucson.org, a religious organization.

# 2022 Affidavit for Organizational Tax Exemption:

When submitting the 2022 Affidavit for Organizational Tax Exemption (See Attached – 2022 Affidavit for Organizational Tax Exemption) to the Pima County Assessor, several errors were made. This was discovered when we recently received tax bills for two parcels. Upon contacting the Pima County Assessor, we were informed that past incorrect years would need to be requested through the Clerk of the Board and submitted to the Board of Supervisors as a request for Relief of Property Taxes.

Parcel ID 123-07-104A - Situs Address 1222 and 1216 N Campbell AV (See Attached – 123-07-104A Assessor Map and 123-07-104A Photo)

On the 2022 Affidavit for Tax Exemption the usage of the parcel was listed as "Rental." This incorrectly conveyed that the entire parcel was used as rental property and generated a tax bill of \$35,898.98. The parcel does contain a 475 square foot studio apartment which is used as a rental. However, the balance of the property is devoted exclusively to church use. Taxes should have been assessed on the value of that rental unit, with the rest of the property being exempt from property tax. We seek the restoration of the balance of this parcels tax exemption, an appropriate assessment and tax on the rental property and the Board of Supervisors tax relief for the appropriate amount and any late fees and interest.

Parcel ID 123-07-101A – Situs Address 1920 E Mabel ST (See Attached - 123-07-101A Assessor Photo and 123-07-101A Tax History)

On the 2022 Affidavit for Tax Exemption the usage of the parcel was listed as "Rental" which is incorrect. This parcel encompasses a portion of the North parking lot for the church, and is used regularly by members of the congregation. The tax history demonstrates that this parcel has previously been granted an exemption and no taxes were due. However, the incorrect listing for the usage as "Rental" generated a tax bill of \$2,988.71. We seek restoration of this parcels tax exemption and the Board of Supervisors tax relief for this amount and any late fees and interest.

### Conclusion:

We sincerely apologize for these errors. They occurred during a time of significant transition and turnover in church personnel. We have established procedures and an internal inventory of all parcels owned by the church and their usage, so that these errors will not be repeated in succeeding years. We thank the personnel of the Assessor's Office, the Clerk of the Board, and the Board of Supervisors for their time and consideration in this matter.







Dear Members of Our Saviour's Community—

Our Saviour's Lutheran Church has been a presence in the Tucson community since well before Tucson had a community college, shopping mall, or zoo. Founded in 1945, Our Saviour's was open for worship before the Catalina Highway to Mt. Lemmon was completed, before Tucson's airport relocated to its present site, and before the Arizona-Sonora Desert Museum welcomed its first visitors. Just as Tucson and the neighborhoods surrounding our church have experienced many changes since 1945, so have the congregation and the ministries at Our Saviour's. Much of the work of the Council involves the ongoing careful stewardship of our congregation's resources to ensure that we will be able to continue to help and serve our diverse community in all of the ways reflected in the other reports included in this Annual Report, and more.

In many ways 2022 felt like a year of growth and new beginnings as we embarked in our first full year with Pastor Amalia, and welcomed new staff in the roles of Minister of Music, Minister of Community Engagement, and Campus Caretaker. To improve efficiency and respond to the evolving staffing needs of our congregation, we reorganized some staffing areas and outsourced bookkeeping duties to an outside bookkeeping service. We worked through the ups and downs of the pandemic together; made numerous repairs to our properties and grounds; and invested time in updating various church policies, including those for building use, non-member weddings, and on-site dogs. This year we resumed the 7:30 worship service, added the new Workshop time on Sunday mornings, and grew in partnership with Lutheran Social Services.

As you may recall, we began 2022 with a balanced budget; thanks to your generous commitment to supporting our congregation and its ministries, our income for the year exceeded our expenses. In gratitude we remember, too, the gifts received as bequests, especially Lois Olsrud's gift of her property and Jo Musser-Kraus bequest. As we turn our attention toward 2023, we're pleased to once again present a balanced budget for your review and approval, and we look forward to the strategic vision conversations planned during the coming year.

When you look ahead to the other reports in this booklet you'll see that the Council's work was just a small part of the many wonderful things that were happening at Our Saviour's in 2022, but I deeply appreciate each Council member's service. I hope you'll share my gratitude for all of the ways Our Saviour's is richly blessed as we begin 2023, and hope you will join me in praying that we'll continue to bring blessings to the ever-changing community around us.

# ANNUAL REPORT FROM THE PASTOR FOR 2022

Siblings in Christ,

A number of years ago, I spent a few months volunteering at Holden Village in the Cascade Mountains of Washington State. One of the practices at Holden Village is evening Vespers – a half hour when the entire community gathers together for worship. Holden Village is rooted in the Lutheran tradition, with expansive wings that reach out to other traditions and those on the edge or beyond the edges of organized faith traditions. This was reflected in worship – one evening we might use the old "Green" Lutheran hymnal. The next night might be a drumming circle. This worked when the community embraced the variety of worship styles and practices. The memory of this served me as a churchgoer – learning to embrace approaches that weren't necessarily my favorite. And giving me courage to invite others to try new things. It's served me too as a pastor – both in worship and community life as I lead us to try new and old things together.

It's an approach Paul writes about in the 14th chapter of Romans – challenging the community to understand and support one another for the common good. This chapter has been a frame for me as I think about the year ahead for Our Saviour's.

During this past year, we've seen a return to many familiar aspects of our life together – a return to the early service in our beloved Chapel, choir, and more congregational gatherings. We are also embracing "newness" in the return – a slightly adjusted schedule that allows for community time. A smaller but mighty choir. An increasingly deeper engagement in the community and projects we care for through our mission support. This is all communal work.

I'm grateful to our committed team. Steve VanMeter has served in the new role of Parish Coordinator with grace and experience among many changes. We had wonderful short term property help, thankfully welcoming John Perez permanently to the role this last summer. We expanded our program staff, welcoming Greta Pasztor as Director of Music Ministry and Sophia Rankin to the new role of Minister of Community Engagement. # Parish Coordinator - submitted by Steve VanMeter

I took on the role of Parish Coordinator at the beginning of 2022, after having been the Publications Coordinator since February of 2018. The role was created due to Kathryn Barrera's departure as Parish Administrator; Parish Coordinator combined much of Kathryn's previous Admin duties with all of my pre-existing duties as Publications Coordinator. An outside bookkeeping firm has been hired to deal with all accounting duties.

As Parish Coordinator, I'm responsible for: organization and publication of all worship bulletins, announcement pages, hymn booklets, website updates, calendar, weekly electronic newsletters, creation of promotional materials, various campus equipment upkeep organization, monthly Roadrunner newsletter coordination, publication and mailing, DVD recording, duplication and mailing to homebound members, archiving, campus building use coordination (including maintaining building use agreement, insurance and organization), weekly bank deposits, volunteer organization, office material ordering, sanitation coordination, service material ordering (including special items such as hymns, ashes, palm fronds, poinsettias, candles, oil, etc), and working with our new tech team on various projects. I've also overseen and organized the transition of our internal tracking software (from Shepherd's Staff to Tithe.ly to Elvanto to Breeze) and trained volunteers on usage.

I look forward to continuing to work with and support Pastor Amalia, the OSLC Council, the Endowment Committee, the Generosity Team and our Congregation in whatever the new year brings.

# Music Ministry - submitted by Gréta Pásztor, Director of Music Ministries

I joined the team in August 2022 as Director of Music Ministries. Our first goal was to "resurrect" the Chancel Choir after over two years of hiatus, which we did, starting in September. We established regular rehearsal times, a singing schedule, weekly communication via group email, and even collaborations with guest musicians. Our biggest program will be presented on Christmas Eve with eight guest musicians, singing three prepared songs with mixed choir (SATB), soloists, piano, flute, and chimes. These last few months have also been a transitional in terms of musical and administrative roles between myself and other staff members. With the addition of the chapel services, we worked out accompanist schedules with members and staff. I was also in charge of communicating with the Bell Choir about when they were playing, as well as inviting guest musicians to play during the offertory.

We also established an updated budget, and made plans for the following year, including hosting the Luther College Nordic Choir in January, finishing the first full Choral season since 2018-2019, and updating the choral library records.

We used our budget to maintain three pianos (installed a humidifier on the Sanctuary piano), purchased music and other materials for the choir, and paid guest musicians and accompanists.

# **Music Ministry/Community Engagement**

Submitted by Sophia Rankin, Minister of Community Engagement

I began 2022 as our Music Coordinator and oversaw much of the Music Ministry until assuming my position as Minister of Community Engagement in August. Throughout the first half of the year, Pastor Amalia and I worked together to expand our Music Ministry with guest musicians and additional special services. We scheduled Lenten services and worked with Lutheran Campus Ministry to offer welcoming and inclusive worship practices during the spring. We reintroduced organists and even a bluegrass band into our services before welcoming our new Music Director Gréta Pásztor in August.

I began my role as Minister of Community Engagement on August 15th, 2022. In this position, I have begun work that will strengthen our bonds to each other within our church, neighborhood, and Tucson community. I primarily work with our middle school youth group, as well as maintain connections with Lutheran Campus Ministry throughout the school year. I also continue work with our Music Ministry by coordinating monthly schedules and musicians with Gréta and Pastor Amalia, as well as repertoire choices throughout liturgical seasons. As we have brought back early-morning services, I also continue to work as an accompanist for some of those services as well as a cantor for the later service.

Since assuming this position, I have hosted and collaborated on multiple events with Pastor Amalia and Scott Koenig, our third youth leader for our middle school group. We have had a scavenger hunt around the church campus, game night, and a visit to Winterhaven during the Christmas season. We even created our own community ofrenda while learning about Día de Los Muertos, which we shared with the entire congregation during workshop together. In this coming year, we are planning on expanding our reach to meet with similar-age Lutheran youth across Tucson. We also plan to have more events involving our entire congregation and Lutheran Campus Ministry while strengthening our youth's connection to each other, the community around them, and their own faith. By July, we are planning to visit Loveland, Colorado for a youth ministry trip that will accomplish these goals while helping us create wonderful memories together.

My goals for this coming year include a focus on different groups within and without our congregation that we can better connect with. As I have primarily been working with our middle schoolers, I also want to connect with specific demographics of 20-to-30-year olds, as well as particularly older members of the congregation. I want everyone to feel my role has a purpose for them. At our ministry fair, I shared my four focus words for this position: community, family, faith, and legacy. As we enter this new year, I want us to make our community feel like a family grounded by a common faith working together to create a positive and lasting legacy.

I am thankful for all this year has brought, especially the groundwork I am beginning to lay in this new role. My hope is 2023 will build upon that foundation and continue to bring new opportunities to us.

Notes to Financial Reports Submitted by Pam Hardman, Treasurer

#### Organization

Our Saviour's Evangelical Lutheran Church (Our Saviour's Lutheran Church) was incorporated as a religious non-profit corporation under the laws of the State of Arizona in 1945. We are exempt from income taxes under IRS Code Section 501(C)3 and the corresponding provisions of Arizona laws. Contributions are deductible by the donor. We are affiliated with the Evangelical Lutheran Church in America (ELCA) and the Grand Canyon Synod.

#### **Accounting Policies**

Our Saviour's Lutheran Church is working with Pinpointe Accounting Services, PC to handle our bookkeeping needs. Pinpointe provides accounting services to many other churches in Tucson and is very familiar with church accounting needs. We have two funds: General and Endowment. Pinpointe writes our checks after invoices have been approved, reconciles bank accounts and provides monthly reports (Profit and Loss and Balance Sheet). Income is posted by church member counters (always 2) at the church and totals are provided to Pinpointe to be included in the monthly reports. Accounting Policies have been written and can be viewed upon request.

#### Rental Houses

Saviour's Lutheran Church owns eight houses within the church neighborhood. All mortgages on the houses have been paid in full. These houses are: 1946 E. Helen, 1948 E. Helen, 1930 E. Mabel, 1135 N. Norris main house and studio), 1221 N. Norris, 1231 N. Norris, 1241 N Norris and the OSLC Annex Apartment. The house at 1241 N. Norris is now the church parsonage. The other houses are rented to qualified tenants, or whenever possible to refugee families. The church also leases the South Parking Lot to the University of Arizona, Monday-Friday, during the day, on a yearly basis. Income from the houses and the south parking lot helps maintain these properties and fund the mission and ministry of Our Saviour's Lutheran Church.

### Endowment Fund Financial Information Submitted by Pam Hardman, Treasurer

The interest received from the ELCA investments, Vanguard investments and the OSLC General Fund is used by the Endowment Team for grants to qualified applicants. Grants from Endowment since 1986 total \$2,080,007.

#### **Endowment Investments**

We currently have three CD's with the Mission Investment Fund. The CD's are:

#7552 – 3 Year Term CD that matures on 12/1/2024 with a fixed interest rate of 1.244%. As of 12/31/22 the balance was \$504,000.00.

#7560 - 3 Year Term CD that matures on 12/1/2025 with a fixed interest rate of 3.016%. As of 12/31/22 the balance was \$498,400.00.

#3574 - 3 Year Term CD that matures on 8/23/2023 with a fixed interest rate of 2.230%. As of 12/31/22 the balance was \$140,000.00.

ELCA Mission Plus Investment #15270 (balance of \$3,719.07 on 12/31/22) is a money market account used for depositing principal payments to the Endowment Fund. The funds in this account are added to longer term investments at the direction of the Endowment Team.

The ELCA Mission Term and Mission Plus Investments are direct unsecured obligations of the Mission Investment Fund of the ELCA, a "Minnesota non-profit corporation." Because the Fund is a corporate entity separate from the ELCA, the ELCA is not liable or responsible for the obligations of the Fund.

A Vanguard 500 Index Fund in the amount of \$322,540.74 and a Vanguard Windsor II Fund in the amount of \$246,500.10 represents the balance of fund investments for the Endowment Fund on 12/31/21.

In the comfort that has developed over the years we have truly achieved "knowledge sharing" to a high degree.

Meetings are held on Wednesdays from 10:30 to 11:30 a.m. in the Activity Building Pocket Room and we adjust our schedules as needed for holy days and vacations. We celebrate each other's birthdays with cake and coffee. Oftentimes group members go to lunch together as we did for Christmas at Guadalajara Grill.

This year for the first time, the Lay Leader Bible Study Group participated in the "Engagement Party" (formerly called the Ministry Fair). It was very interesting to hear about people's family Bibles and to answer questions about the Bibles we use in our group and how we operate.

In 2023 we will continue reading the New Testament. Through group participation we leave each week with a deeper understanding of what we have read. Our completed quilts were donated to various organizations including AVIVA, Pepe's House, Tucson House, Pima Council on Aging (Vail) as well as members of our church and wall hangings to decorate the nursery. We made graduation quilts for our high school seniors and were able to donate quilts to Desert Hills Lutheran Church in Green Valley for their charity auction. In addition we gave a large collection of Christmas fabric to St Mark's Methodist Church in northwest Tucson to help them in their mission to make holiday quilts for local charities. Bags in a variety of colors and styles were made and given out to our wonderful new church members

The quilters/knitters closet is organized and beautiful, thanks to the hard work of both groups. We certainly appreciate our space which has allowed us to accomplish so much this year. New quilters (no experience necessary) are always welcomed.

#### Altar Guild - submitted by Mary Durham-Pflibsen

Altar guild is a small but dedicated group of members who set up communion and prepare the sanctuary for worship each week. We ensure that the paraments, banners and decorations are changed to match the liturgical day and season, flowers are purchased and arranged, candles are filled with oil and communion service is set up on the altar. After worship, we wash and put away the communion service and wash/press the linens. We also keep inventory of supplies (bread, wine, candle oil, etc.) and notify the office when supplies need to be replenished. We dust, polish and clean the altar area and sacristy as needed.

This year, due to a Ward 6 pilot recycling initiative, we began recycling the individual plastic cups used for wine at Sunday worship. We are thrilled to have this opportunity to reduce our environmental impact while keeping communion service safe and healthy for all.

We would love additional volunteers to help with setup and/or cleanup after worship services. Many hands make light work! We are hoping to gather enough altar guild members to ensure that each person only needs to volunteer once or twice a month. #### Tucson Interfaith HIV / AIDS Network (TIHAN) \*

OSLC is one of 48 faith communities supporting Tucson-area people living with HIV/AIDS (CarePartners) and their families through TIHAN. Support from our congregation has been strong in 2022 and is greatly appreciated. Most CarePartners have low income. Higher inflation levels have adversely impacted them and the TIHAN organization this year.

In April 2022, OSLC hosted the Poz Café, a monthly gathering to provide CarePartners with a good lunch and a care package of useful household and personal hygiene products that they aren't able to obtain using "food stamps" and often can't afford otherwise. OSLC members generously donated toilet paper, paper towels, laundry detergent, shampoo and disinfecting cleaner for the care packages. Additionally, several OSLC members volunteered their time to deliver, pack and distribute items collected for care packages as well as packing and distributing the box lunches. Although the 2022 Poz Café luncheons were held as outdoor drive/walk/bike-through events, we are hopeful that we might transition back to in-person luncheons in 2023 depending upon community covid levels.

In December, our congregation contributed over \$2,000 worth of gifts, gift cards and cash to brighten the holidays for our CarePartners.

The OSLC Endowment also awarded grants totaling \$1,100 to support TIHAN in 2022.

Please watch for announcements in the coming year for opportunities to continue OSLC's support of TIHAN. These will include the annual spring toiletry drive and holiday gift drive, as well as opportunities to volunteer for the April 2023 Poz Café. At present the study is approaching Moses receiving the 10 commandments and the golden calf incident.

The study participants include OSLC current and former members as well as men from all walks of life and faith backgrounds. This makes for lively and insightful discussion of the Bible's texts. We are grateful for the opportunity to meet and study the scriptures.

Sound and Streaming - Submitted by Tracy Ratliff

In a corner of the balcony is the sound and streaming bench. Each Sunday and for many special events a small team of dedicated individuals sets up and runs the equipment to fill the sanctuary with the sounds of our worship. When all goes well, the pastor's sermon is vibrant; the musicians fill the sanctuary with sound; and the readings are clear and crisp. When all does not go well, we make corrections, adjustments and change the batteries in the microphone.

We have always had a sound system to enhance our worship experience. We have, for many years, recorded the worship service and provided it, in the form of CDs, to members who cannot attend. With the pandemic the church invested in the hardware, software and volunteers that allow us to live stream our Sunday morning services and special events to our YouTube channel. The service is also recorded – now both sound and video – and provided on DVDs for those who prefer that mode of technology. Individual headphones sets are available to those who require a little extra sound enhancement.

The most important aspect of this ministry that I would convey to the congregation, however, is not the hardware, but the efforts of our volunteers. Members arrive early to set up, switch microphones and video views during the service, and then put the equipment away after the service. Several of our young adults are essential members of that team. As time has passed, it has been a delight to see how they have grown in their ability and confidence.

We would welcome and encourage anyone with an interest to join our team. This important ministry allows us not only to support our members who cannot attend on Sunday morning but to reach beyond our walls to friends and family and those

whom we have never met.

#### Casa Maria Soup Kitchen An Our Saviour's Community Outreach Project

- Submitted by Quentin Peterson

Every eighth weekend in the past three+ decades, volunteers from this Church

have delivered sustenance & supplies to Casa Maria Soup Kitchen, aka Capilla de Nuestra Señora de Guadalupe Y Cocina Gratis, a Catholic Social Ministry.

Our Church community used to do so much more than we do now, but that is primarily a response to the needs of the soup kitchen located at 352 E. 25th Street South Tucson, as well as a reevaluation of the way 'we have always done things'. The primary motivator for our change was the pandemic. Let me first illustrate how we used to do this vital ministry. Every eight weeks we used to:

Buy enough bulk sliced bologna to prepare ~2300 sandwiches Buy mustard and bread to prepare those sandwiches

Buy cookies, bulk fruit in cases amounts, vegetables for soup fixings and sandwich

We would assemble in the Activity Building kitchen and adjoining rooms to assemble our goodies for delivery to the soup kitchen that same day

We had to change our entire process of provisioning Casa Maria at the onset of the Pandemic, starting in Spring of 2020. Now, instead of meeting collectively in the Activity Building to prepare the sandwiches, cookies and soup fixings, we scaled back and relied on volunteers to bag cookies in their own homes, collected and delivered them with any other requests that the staff of the soup kitchen made. Once I began to ask the staff ahead of delivery for their requests at that time, it became really clear to me what they really needed. And I did ask them specifically about the foodstuffs we had previously supplied. They typically said they had enough foodstuffs from other sources, but did request sundry items such as Chlorox, PineSol, disposable gloves, plastic soup spoons, and cups for dispensing soup. They may ask at times for bulk bologna, but it's pretty clear that we have shifted our focus in this ministry. I say this is a vital ministry, because the people served at this Catholic Social Ministry are oftentimes homeless and thus can't qualify for Tucson Community Food Bank boxes.

#### Visitation Ministry

In June of this year, we gave thanks to Pastor Mateo Chavez for his work providing visitation support through a grief support group (online), phone calls, and other support during COVID. Pastor Mateo had let us know that he needed to invest more time into his congregation, San Juan Bautista. We give thanks for a continued partnership between our "cousin" churches (Our Saviour and San Juan Bautista) through Spanish classes taught by Pastor Mateo and Annette Chavez, shared youth activities, La Casa de Misericordia, and other shared work. We will be working to expand our lay-led visitation ministry in the coming year.

Endowment Committee - submitted by Quentin Peterson

Our Endowment Fund has well over \$1.7million in investments. These investments are in relatively conservative (by any metric) funds (Vanguard and ELCA) that currently pay single digit interest rates, and the income generated in 2022 was approximately \$xx,000.

Our Saviour's Lutheran Church by-laws govern how the income is to be allocated: at least 15% of it goes to ELCA Mission projects, 20% is used to pay for Community Outreach charities and/or projects, 20% of our income funds some of the maintenance, repair and/or renovation of our Church structural facilities, and 10% of investment income must be re-invested with the principal, which, if the principal is invested prudently, oughta continue 'growing' the Fund. The remaining 35% is available for other grant applications.

This year, our Endowment Fund generated \$43,609 income from the principal, and the amount that was re-invested into the principal was \$4,407. We approved Grants from applications made this year that totaled \$40,182. If you do the math, those figures alone may give the impression that we 'spent' more this year than the fund earned, but in reality, the Endowment Fund started 2022 with a surplus of \$7,458, which was 'unspent' income, leftover from 2021, even after meeting our By-Laws' obligations and paying other Grants that year.

Our Endowment Fund was formed in 1986 with a generous starter donation, and since then, over \$2 million has been given out. Over half a million dollars of that has been granted to OSLC projects.

This year, our team members met quarterly on Zoom, and discussed and agreed (via email) on issues that needed a quicker resolution than our regular quarterly meetings

I want to thank all Endowment Fund members, past and present. Our current

Our Saviour's Lutheran Church, Tucson, Arizona (ELCA congregation code 05002; U.S. federal employer identification number 86-0135786) is listed on the official roster of congregations of the ELCA.

Our Saviour's Lutheran Church was listed on page 41 of the Group Exemption List filed with the IRS by ELCA in November 1988.

The inclusion of Our Saviour's Lutheran Church in the ELCA's Group Exemption List as described above establishes that this congregation is exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code and is not a private foundation as defined in Code Section 509(a).

The <u>four-digit</u> Group Exemption Number <u>9360</u> is the same for the ELCA, its synods, its congregations, and its related entities. The <u>nine-digit</u> Employer Identification Number is different for each synod, for each congregation, and for other employing entities. The nine-digit number is used, for example, when federal withholding and Social Security contributions are filed by the employer.

This assignment of the four-digit group exemption number to the ELCA and its related entities does not change the previously assigned Employer identification Number that synods, congregations and other organizations already have.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day associated ourselves together for the purpose of organizing a religious, non-profit corporation under the laws of the State of Arizona, and for that purpose hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation shall be OUR SAVIOUR'S EVANGELI-CAL LUTHERAN CHURCH, and its principal place of business shall be Tueson, Fima County, Arizona.

#### ARTICLE II

The date of the commencement of this corporation shall be the date on which a copy of these Articles of Incorporation, duly certified by the Arizona Corporation Commission, are filed in the office of the County Recorder of Pima County, Arizona, and it shall continue for a period of twenty-five (25) years thereafter, with the right of perpetual succession.

#### ARTICLE III

The purposes of this corporation shall be the worship of God; to engage in religious activities in all its branches; to perform missionary and educational work; to maintain schools, colleges, or universities, for the purpose of carrying out its educational work, and to administer the teachings, sacraments, and other rites and ceremonies of the church, according to the canons of the Evangelical Lutheran Synod of California and of the United Lutheran Church in America.

For the further purpose of taking over and acquiring real, personal, and mixed property; and to own, acquire, hold, mortgage, encumber, lease, convey, and dispose of real and personal property, of all kinds; and to own and establish schools, colleges, churches, missions, and/or chapels, in Pima County, Arizona. The corporation

shall have all powers permitted and granted by the laws of the State of Arizona to a corporation of a religious, educational, eleemosynary, and non-profit character which are necessary or may be necessary and proper for carrying into effect any of the purposes of said corporation.

#### ARTICLE IV

This corporation shall have the power to borrow money and to secure the payment of the same by mortgaging, pledging, or in any other manner encumbering its real or personal property; with the limitation that the highest amount of indebtedness to which the corporation may subject itself shall be the sum of ONE HUNDRED THOUS-AND AND NO/100 (\$100,000.00) DOLLARS.

#### ARTICLE V

This corporation shall have no capital stock, and membership in the congregation of Our Saviour's Evangelical Lutheran Church, as defined by the canons of the United Lutheran Church in America, shall constitute membership in this corporation.

#### ARTICLE VI

Business affairs of this corporation shall be conducted by a Board of Directors and/or Church Council, which shall be composed of not less than five (5) nor more than fifteen (15) members, as determined by the by-laws of this corporation, and who are to be elected and qualified in compliance with the by-laws of this corporation. Said Board of Directors and/or Church Council members shall serve for a period of three (3) years, or until their successors are duly elected and qualified. The Board of Directors and/or Church Council shall be elected at its annual meeting, to be held on the second Sunday of January of each year, or at any adjournment thereof, and the Board of Directors and/or Church Council shall elect the following officers: A president, who shall be the pastor, or acting pastor of said church; a vice-president, a secretary, and a treasurer, and such other officers as the Board of Directors and/or Church Council may authorize, and their terms shall

extend to the next annual election of officers. Two or more of the offices may be held by the same person. The aforesaid Board of Directors and/or Church Council will be elected in a regular manner by a majority vote of a quorum of the members of said corporation present at a regular or special meeting of the congregation of this church, all of which members shall have been duly notified of said election. However, any such member elected to said Board of Directors and/or Church Council shall be a member of said—congregation in good standing at the time of said election.

#### ARTICLE VII

We have considered your application for a group exemption letter recognizing your subordinates as exempt from Federal Income Tax as organizations of the type described in Section 501(c)(3) of the Internal Revenue Code.

Our records shows that you were recognized as exempt from Federal Income Tax under Section 501(c)(3) of the Code. The exemption letter remains in effect.

Based on the information supplied, we recognize your named subordinates on the list you submitted as exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code.

Additionally, we have classified the organizations you operate, supervise, or control, and which are covered by your notification to us as organizations that are not private foundations because they are organizations of the type described in Sections 509(a)(1) 509(a)(2) or 509(a)(3) of the Code.

Donors may deduct contributions to you and your subordinates as provided in Section 170 of the Code. Bequests, legacies, devises, transfers, or gifts to you or for your use are deductible for Federal Estate and Gift Tax purposes if they meet the applicable provisions of Sections 2055, 2106 and 2522 of the Code.

You and your subordinates are not required to file Federal Income Tax Returns as long as a tax-exempt status is maintained. But under Section 511 of the Code, an organization is subject to tax on its unrelated business taxable income. You are not required to file Form 990, Return of Organization Exempt from Income Tax, if you meet the exception in Section 6033(a)(2)(A)(i) of the Code. 

#### **COMMITTEE GENERAL GUIDELINES**

C.R. 13.01-01 Congregation committees shall be established as needed by the Church Council. Committees shall be established and organized, and shall function, in accordance with these General Guidelines and with the scope

of authority and responsibility specified in guidelines (Continuing Resolutions) adopted for each committee.

- 1. Three types of committees shall be recognized
  - a. <u>Standing Committees</u> are permanent committees reporting directly to the Church Council, whose authority and responsibilities relate to the administrations of a logical portion of the ongoing church mission activities (worship, learning, witness, service, and support). Examples of Standing Committees include the Finance, Stewardship, Nominating, and Endowment Committees.
  - b. <u>Sub-Committees</u> are committees reporting to Standing Committees whose authority and responsibilities are the administrations of assigned segments of Standing Committee responsibilities.
  - c. <u>Special Committees</u> are task forces or *ad hoc* action committees whose authorities and responsibilities are limited in scope and time to the unique task(s) assigned. Upon task completion, Special Committees are dissolved. Examples of Special Committees include the Archive Committee and Personnel Committee.
- 2. Each committee shall elect amongst themselves a Chairperson or Co-Chairpersons. A Vice-Chairperson may be elected by the committee if the work so dictates. Each committee shall select a recording secretary from its membership.
- 3. Committee members, as required, are recruited and appointed by the respective chairpersons. Members' names are submitted to the Church Council. Chairpersons shall recruit and encourage the congregation's members to serve on committees where their individual gifts and talents can contribute to the programs of the committee.
- 4. The term for committee membership is indefinite when not otherwise specified. Chair appointments and membership lists shall be published at least annually in the Annual Report.
- 5. The Senior Pastor and the Council President shall serve as ex-officio voting members of all committees.
- 6. Standing Committees shall meet as necessary and include time for long-range planning and fellowship. Sub-Committees and Special Committees shall meet as work dictates.
- 7. Committee Chairpersons shall be responsible for arranging for meetings, preparing and distributing agendas, conducting meetings, and for making regular reports to the Church Council. The Chairperson is expected to devise a system for notifying all members of each meeting.
- 8. The time and place for the meetings of all Committees is to be coordinated with the schedule maintained in the church office.

- 9. Committee Chairpersons shall coordinate committee actives with appropriate church staff and shall establish appropriate approval procedures for committee commitments, expenditures, and actions.
- 10. Committee Chairpersons or ministry leads shall, with the assistance of the Church Council or Finance Committee (as needed), prepare and present budget requests for committee operations. They shall monitor committee expenditures and/or income on a regular basis to assure compliance with committee planning.
- 11. The Committee Chair or Council Representative shall make appropriate recommendations and presentations to the Church Council.
- 12. Committee actions should include:
  - a. General internal communication and coordination.
  - b. In-Committee motions—motions related to the committee responsibility and within committee authority.
  - c. Motion to Council—motions related to committee responsibilities beyond committee authority.

#### FUND-RAISING C.R. 14.01.A-1

All fund-raising activities at Our Saviour's Lutheran Church (at the church proper and/or in, among, and by any groups and organizations within the congregations, formally recognized or informal in nature), must have prior approval by the Church Council, or in the cases of extreme emergency only, the approval of the Church Council officers and Senior Pastor, and must directly benefit the church and/or its ministries.

- 1. Sale of items on OSLC Campus
  - a. No members of the congregation, or nonmembers, may sell items or solicit customers on the OSLC campus without required approval described above.
    - An exception to this would be books written by one of our guest speakers/presenters at events such as the Sunday Forum.
  - b. Members of the congregation may take orders off campus (i.e. via phone, email, etc.) for items such as cookies, products, and/or services and may collect money and deliver items on OSLC campus for these previously ordered items.
  - c. No solicitation of donations of any kind may be made on OSLC campus or through OSLC publications and website except for those specifically approved by the OSLC Church Council (such as the Youth-sponsored rummage sale).
- 2. Games of Chance
  - a. No form of gambling is allowed on OSLC campus.

b. Raffles are considered a form of gambling, and as such, are not permitted by any group or organization connected to, using facilities at, or renting space on the OSLC campus.

#### COUNCIL MEMBER DUTIES & OBLIGATIONS

C.R. 15.01

The OSLC Congregational Council directs the strategy for the business operations and ministries of the church. It is an opportunity to serve in a leadership role while representing the needs of the church's members, guests and greater community.

- 1. All members are expected to attend monthly council meetings generally held on the 3<sup>rd</sup> Tuesday of the month from 7:00-9:00 p.m., an additional meeting held in January specifically for the budget, and the annual congregational meeting generally held in January or February.
- 2. Each Council member serves in at least one ministry or committee during his or her three-year term.

Persons considered for Council must be active members of the church as defined by supporting the mission of the church through worship and a stewardship pledge of time, talent, and treasure. Active, prayerful participation in meetings by council members ensures that the church is not only acting with sound business practices, but actively seeking God's will for the congregation and how we serve our community of Tucson. The Council delegates our responsibility of Constitution Sections C12.04;

C.R. 15.01a

The Council delegates our responsibility of Constitution Sections C12.04 Item g, and Section C12.08 to the Senior Pastor.

#### NEW COUNCIL MEMBER ORIENTATION AGENDA

C.R. 15.02

An orientation session shall be held for all new council members. The session is to be held as soon as possible subsequent to the installation of new Church Council members, and, is to occur no later than the  $2^{\rm nd}$  regular Church Council meeting following the installation, unless redirected by Church Council.

#### GIFT RECEPTION POLICY

**C.R. 18.01-2** consistent

Our Saviour's Lutheran Church solicits and accepts gifts that are

with its mission and that support its core programs, as well as special projects.

- 1. Financial donations and other forms of support will generally be accepted from individuals, partnerships, corporations, foundations, government agencies, or other entities.
- 2. Gifts of Real Property, Personal Property or Securities may be accepted only upon prior approval of the Church Council.
- 3. Material donations, such as housewares, fixtures or furniture, will be accepted only for designated purposes, such as fundraising rummage

sales. All material donations will be disposed of (kept, sold, donated,

etc.)

at the discretion of the staff and church leadership.

4. Financial gifts that come with a designation from the donor will be considered for designation only if more than \$5,000.00, and then will be designated only at the discretion of the Church Council.

#### **BUDGET PROCESS**

C.R. 12.05-C

The process for preparing the OSLC budget is as follows:

<u>September 1</u> – All persons responsible for line items in the budget are sent the expense ledger for their items year-to-date and a request to provide the following year's needs.

October 15 – All budget requests are provided to the Parish Administrator and these are input to the following year's budget in Column B.

<u>Late October or Early November</u> – The income side of the budget is discussed at length at a Finance Committee meeting looking at the current

year as a guide for the next year. The expense requests are also reviewed for consistency with history and with justification for increase or decrease. A general summary of the process is presented to the Council at their November meeting.

November and Early December – Concerns regarding expense items that seem higher than necessary or cause questions within the Finance Committee are expressed one-on-one with the individuals responsible; budgets are adjusted if agreed to by both parties. Meetings are held with the Senior Pastor to review concerns and discuss solutions to a potential non-balanced budget.

<u>December Council Meeting</u> – The prospective budget as it stands without the year-end income is reviewed and discussed with the Finance Committee at the council meeting. The Council is asked to raise any and all questions or concerns they might have.

Early January – The Council meets in a special session to approve a budget for presentation to the Congregation. At this meeting the specific income side of the budget is reviewed and determined (what we will budget for envelope giving, gratitude gifts, etc.). The expense side has been reviewed by all parties and is determined assuming that the income is adequate to support it.

# ENDOWMENT FUND GUIDELINES C.R. 4.03-g-1

A. Purpose of the Fund

The purpose of the Fund shall be to support the mission of the Church to the glory of God with the current mission statement of OSLC as a guide.

#### B. Eligibility for Grants

- 1. Projects must fit within and be explicitly related to the current mission statement of OSLC.
- 2. Both the ministries of OSLC and its broader mission shall be considered in submitting applications, which may include benevolences, special projects and congregational ministries which are above and beyond regular operating expenditures.
- 3. Grants shall be made for specific ministries rather than to other institutions for their discretionary use.

#### C. Application Procedures

- 1. Requests for funding shall be submitted on forms provided by the Endowment Committee to the church office and placed in the mailbox for the Endowment Committee.
- 2. Applications will be reviewed quarterly by the Endowment Committee. Applications are due to the church office on the first of the Endowment Committee meeting month. The Endowment Committee shall normally meet February, May, August, and November.

#### D. Distribution of Grants

All grants shall be paid directly to the institution or agency designated by the applicant and as agreed upon by the Endowment Committee.

E. The Senior Pastor is a permanent voting member of the Endowment Committee. In addition, the Church Council shall appoint four voting members of OSLC (two each year) to the Endowment Committee for two-year terms. Members cannot be appointed for more than two full terms consecutively. Nominations for committee appointments shall be recommended by the Council officers and the Senior Pastor to the Church Council. Terms begin January 1. When a member resigns before the end of term, a replacement shall be appointed by the Council to complete that term.

#### **BYLAWS**

#### ENDOWMENT FUND

C4.03-bl The congregation's responsibility to motivate its members to provide financial support for the congregation's ministry and the ministry of the ELCA shall include motivation to support the future work of the church through bequests and memorial gifts. The Church Council shall establish programs on behalf of the congregation to encourage such gifts and shall administer them in such a way that they encourage the responsible stewardship and on-going support of the members. The Endowment Fund (established in 1986), whose operation and procedures shall be defined in these Bylaws and by Continuing Resolution adopted by the Church Council, was established and will be maintained as one of the means of fulfilling this responsibility.

#### A. Endowment Fund Principles

- 1. Christian stewardship involves the faithful management of all the gifts God has given to humankind the created world; the gospel; life; time; abilities; and money, including accumulated, inherited and appreciated sources.
- 2. The scriptural principle of proportionate giving, to return to the Lord a portion of the gifts God has first given to his beloved children, is both a privilege and an appropriate response in all times and circumstances. Christians, therefore, are encouraged to give to the work of the church. Gifts will be received according to the church's Gift Reception Policy.
- 3. It is the desire of Our Saviour's Lutheran Church to encourage, receive and administer these gifts in a manner consistent with the loyalty and devotion to our Lord expressed by the donors and in accord with the policies of this congregation.
- 4. The purpose of the Endowment Fund is to enhance the mission outreach of Our Saviour's Evangelical Lutheran Church. Endowment Fund principal shall be prudently managed and invested to ensure safety and security of principal with growth and income. Ten percent annually of the endowment fund income shall be invested for growth of principal.
- 5. The Endowment Committee shall be the custodian of the Endowment Fund for the Church Council, administering the FUND under these Bylaws.

#### **B.** Committee Membership

- 1. The Senior Pastor is a permanent voting member of the Endowment Committee. In addition, the Church Council shall appoint four voting members of OSLC (two each year) to the Endowment Committee for two-year terms. Members cannot be appointed for more than two full terms consecutively. Nominations for committee appointments shall be recommended by the Council officers and the Senior Pastor to the Church Council. Terms begin January 1. When a member resigns before the end of term, a replacement shall be appointed by the Council to complete that term.
- 2. The COMMITTEE shall meet at least quarterly, or more frequently as deemed by it to be in the best interest of the FUND.
- 3. A quorum shall consist of three members. Three or more affirmative votes shall be required to carry any motion or resolution.

- 4. The COMMITTEE shall elect a chairperson from its lay membership and shall elect or appoint a secretary. The secretary may be chosen from outside the Committee, in which case the secretary shall have voice, but not vote. The chairperson, or member designated by the chairperson, shall preside at all COMMITTEE meetings.
- 5. The secretary of the COMMITTEE shall maintain complete and accurate minutes of all meetings and supply a copy thereof to each member of the COMMITTEE. The secretary shall supply a copy of the minutes to the Church Council.
- 6. The Parish Administrator shall work with the Council Treasurer in maintaining and coordinating complete and accurate accounts for the FUND. Checks and all other necessary documents shall be signed according to the church's Check Signing policy. Reports will be prepared for the COMMITTEE in advance of all regular meetings and for the Church Council at each regular meeting. The books shall be reviewed annually by a certified public accountant or other appropriate person who is not a member of the COMMITTEE.
- 7. The COMMITTEE shall report at each annual meeting of the congregation and shall render a full and complete reviewed account of the administration of the FUND during the preceding year.
- 8. The COMMITTEE may request staff and other members of the congregation to serve as advisory members and, at the expense of FUND income, may provide for professional counseling on reinvestments or legal matters as it deems to be in the best interest of the FUND.
- 9. Members of the COMMITTEE shall not be liable for any losses which may be incurred upon the investments of the assets of the FUND except to the extent such losses shall have been caused by bad faith or gross negligence. No member shall be personally liable as long as he/she acts in good faith and with ordinary prudence. Each member shall be liable only for his/her own willful misconduct or omissions and shall not be liable for the acts or omissions of any other member. No member shall engage in any self dealing or transactions with the FUND in which the member has direct or indirect financial interest and shall at all times refrain from any conduct in which his/her personal interest would conflict with the interest of the FUND.
- 10. All assets are to be held in the name of Our Saviour's Evangelical Lutheran Church.
- 11. Decisions to hold, sell, exchange, rent, lease, transfer, convert, invest, reinvest, and in all other respects to manage and control the assets of the FUND, including bank deposits, stocks, bonds, debentures, mortgages, notes, or other securities or investment's as in their judgment and discretion they deem wise and prudent, are to be made by the COMMITTEE, with subsequent execution by the delegated member of the COMMITTEE.

#### C. Distribution of Fund Income

- 1. Endowment Fund income not invested for growth of principal should be distributed as grants and allocated as follows:
  - a. A minimum of 20% for outreach into the community and synod, including, but not limited to, grants to ELCA seminaries, colleges or students attending such schools, social service agencies, institutions and agencies to which this congregation relates, and to special programs designated for those persons in our parish area who are in spiritual and/or economic need.
  - b. A minimum of 15% for missions of the ELCA in this continent and worldwide, including, but not limited to, grants to the ELCA for new congregational development in North America, professional leadership, educational ministries, global mission, ecumenism, evangelism, social ministries, and capital financing.

- c. A minimum of 20% for facility preservation, capital improvements and repairs, debt reduction, or building programs.
- 2. Distribution of the total FUND income should occur annually at the discretion of the COMMITTEE.

#### D. Distribution of Principal

When Congregational circumstances are so dire and of such an emergency nature that the future of the congregation is at stake and that the only recourse seems to be the use of the FUND principal, the Church Council may, upon a two-thirds majority vote, recommend such authorizing action to the congregation. The congregation shall consider such action under the notification and voting rules established by chapter 10 of the constitution. The congregation may then, with a 10% quorum of voting members, authorize expenditure of the FUND principle with a two-thirds majority vote.

#### **ORGANIZATIONAL CHARTS**

C4.04-bl

The church council shall maintain current organization charts portraying committee structure and staff organization and structure. Such charts and associated organizational responsibilities and staff job descriptions shall be enacted and maintained current by the church council as continuing resolutions.

#### MISSION STATEMENT

C4.05-1

The current mission statement of Our Saviour's Lutheran Church shall be maintained and reviewed by the church council every five years, revised as necessary, and submitted to the congregation for consideration and adoption if revised. The mission statement will be included in the annual report and the historical record of mission statements shall be kept by the archive committee.

The current mission statement, adopted August 2012, is:

"In the Spirit of Jesus, we grow in faith through worship and education while nurturing and serving God's community."

#### **DEFINITION OF INACTIVITY**

C8.05.e-bl The

The congregation's responsibility for fostering faithful membership shall include continuing and conscientious pastoral care for members in an effort to encourage fulfillment of their duties and responsibilities.

When members do not partake of Holy Communion, do not support the church with their offerings, and/or fail to participate in the life and worship of the congregation for a period of two consecutive calendar years; they may be removed from the roll of members by the church council.

These procedures will take place only after such members have been counseled about the matter, if possible. Such persons who have been removed from the roll of members shall remain persons for whom the church has a continuing pastoral concern.

#### DATE OF ANNUAL MEETING

C10.01-bl The annual meeting of the congregation shall be held in the January/February time frame on a date or dates set by the church council. The annual meeting will include the election of the church council.

#### **DUTIES OF OFFICERS**

#### C11.01.a-bl A. President.

The president shall serve as president of the congregation and ex-officio member of all committees. The president shall serve as chairperson and preside over congregational and church council meetings, or designate the Vice-President to serve as chairperson. In addition, the president shall:

- 1. Prepare the church council agenda in consultation with the senior pastor;
- 2. Call special meetings of the church council;
- 3. Recommend to council the appointment of special committees; develop, in consultation with the senior pastor, the nature and duties of such committees;
- 4. Attend, from time to time, the meetings of the committees in order to develop an understanding of the various ministries of the congregation;
- 5. Work with the senior pastor and the church council to promote a climate of mutual understanding, peace and goodwill within the congregation.

#### B. Vice President.

The vice-president shall preside over congregational and church council meetings as the chairperson in the absence of the president or as designated by the president.

#### C. Secretary.

The secretary shall:

- 1. Keep or oversee the keeping of accurate minutes of all meetings of the congregation and the church council;
- 2. Maintain records of the minutes of the congregation and church council;
- 3. Prepare correspondence and communications as requested by the church council;
- 4. Provide ballots for election of church council-persons at the annual election;
- 5. Perform other duties normally associated with the position of secretary as requested by the church council.

#### D. Treasurer.

The treasurer shall:

- 1. Supervise the keeping of the books of account with the parish administrator to make sure that funds are disbursed only on proper authority, and that monthly remittance of benevolence are made to the treasurer of the synod;
- 2. Serve as a resource to the church parish administrator regarding methods of keeping the books of account of the congregation, methods and selection of bank accounts for safekeeping of church funds, and methods of reporting financial information to the church council and congregation;

3. Serve as a member of the finance and stewardship committees.

#### **AUTHORIZED CHECK SIGNERS**

C12.05-bl Checks may be signed by the following persons, in this preferred order:

- 1. Elected officers of the church council
- 2. Parish administrator

No check signer may sign a check to which they have a conflict of interest.
