Agenda Item #47 Health CDC Racial & Ethnic Community Health (GR-GTAM-24-32)

This project proposes to TARGET American Indian (AI) and Mexican-American (MA) populations to vaccinate against flu and COVID throughout Pima County. Is this targeting project identified as such because that specific population does not participate enough previously or are you using that population to support COVID human-data health responses? One small study of 50 humans showed ineffectiveness of COVID vaccines, past and updated. Previous activity by CDC and Dr. Theresa Cullen does not provide confidence in the health decisions and COVID projects by Pima County. Do you remember during the Arizona State confirmation hearings of Theresa Cullen for the State Health Dept position, she indicated she does not make the health decisions for Pima County only provides information. So she "threw you under the bus". NONE of you are qualified to make health decisions for an entire community.
