Addendum 2. Agenda Item #1. Update Discussion - Status of Legal Asylum Seeker Program in Pima County. **SUPPORT JAN LESHER'S RECOMMENDATION.** NO county dollars should be spent on immigration activities, as the county admits this is a federal issue. In her Petition to the Pima County BoS, Mrs. Curtis, the pastor's wife, describes the hardship the church endured starting in 2019 and how the church fell into delinquency in filing for yearly exemptions. Since the hardship began, the church has been intentional and on time in filing with the Arizona Corporation Commission, believing this was all that was required in filing for tax exemption. Pima County offers a Valuation Relief Program and the church has filed paperwork to qualify. This church shows no income from property rentals, etc., and as they are a small congregation. EXERCISE compassion and either look further into the circumstances of this petition, or forgive the delinquency today, as you would have done, if you were considering a tax exemption form, after all.

Agenda Item #15: Monthly Financial Update: WE EXPECT THAT THE BOS WILL DO DUE DILIGENCE TO GET THE BUDGET UNDER CONTROL. One of the ways we suggest is to

The County government should not be in the business of promoting medical treatments. The HPV vaccine is increasingly being associated with severe adverse effects. There is no evidence that it prevents cervical cancers; in fact it may increase such cancers and at an unusually young age. HPV is a sexually transmitted disease and thus results from unhealthy lifestyle choices; it is not transmissible in public settings except where unhygienic behavior such as sharing towels is promoted.

Florida Surgeon General Ladapo, with the support of 17,000 physicians, recommends against COVID-19 vaccine, and some countries have taken it off the market at least for young people.

If the liability shield that protects vaccine manufacturers and providers is breached, say because of fraud, the county could face huge liability.

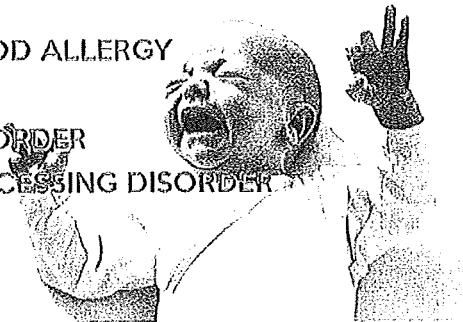

#31 The wording on this agenda item is particularly alarming: "to develop and support ongoing strategies to promote the immunization rates of PC children, teens and adults **with emphasis on the C-19 shot**". Has the BOS spent one single minute doing research to find out about the adverse events caused by the c-19 bio-weapon? Have they read about myocarditis and other events?

This study:

Cardiovascular complications have been identified as consequences of COVID-19 infection and COVID-19 vaccines.^{1,2} Sun et al³ showed an increase of >25% in cardiac arrest/acute coronary syndrome emergency calls in the 16- to 39-year-old population during January to May 2021, and they found a significant association with the rates of first and second vaccine doses.

Or this study:

...identified 1691 studies and, after screening for our inclusion criteria, included 14 papers that contained 28 autopsy cases. The cardiovascular system was the only organ system affected in 26 cases. In two cases, myocarditis was characterized as a consequence from multisystem inflammatory syndrome. The mean age of death was 44.4 years old. The mean and median number of days from last COVID-19 vaccination until death were 6.2 and 3 days, respectively. We established that all 28 deaths were most likely **causally linked to COVID-19 vaccination** by independent review of the clinical information presented in each paper.
