To Whom It May Concern:

I'm a 65 year old Disable Army Veteran with many pre-existing medical conditions. I'm considered a medically vulnerable adult. My husband is 68 is also considered medically vulnerable.

Were not protected under the CDC Protective Order preventing eviction. Although I've answered yes to five Questions relating to my health I'm excluded from eviction protection.

The CDC Protective Order is geared toward those with HUD Section 8 Subsidies, City of Tucson Housing Subsidies, etc.

We have pending date for eviction on January 25, 2021. I reached out to my Sioux Tribe in SD discovering the Federal Government gave substantial monies for medical care, burial care, housing assistance, utility assistance, cash stimulus for me and my three kids to my Tribe.

They refuse to assist me with resources to prevent my eviction. I am excluded from most City, County, State, and Federal Subsidies. My normally \$821 is up to over \$1,000. Are there any emergency resources for people such as us???

SD US Attorney, AZ US Attorney said it's illegal during Pandemic to evict for non-payment only. Could I get clarification as to why we aren't all protected under the CDC Protective Order???
