CONTRACT AMENDMENT

WHEREAS, Pima County, a body politic and corporate of the State of Arizona, hereinafter called COUNTY, and AWASA, d.b.a. Animal Welfare Alliance of Southern Arizona, hereinafter called CONTRACTOR, have entered into a Contract for the provision of spay and neuter clinics on behalf of Pima Animal Care Center; and

WHEREAS, COUNTY and CONTRACTOR desire to amend said Contract to extend the term and increase the funding to continue to provide services in Pima County.

NOW THEREFORE, it is agreed as follows:

1. Replace Article I – Term and Extension/Renewal, with the following:

> "This Contract shall commence on December 14, 2009 and shall terminate on March 13, 2014 unless sooner terminated or further extended pursuant to the provisions of this Contract. The parties may renew this Contract for up to nine (9) additional months or any portion thereof. Any modification, or extension of the contract termination date, shall be by formal written amendment executed by the parties hereto. Amendments to the Contract must be approved by the Board of Supervisors or the Procurement Director, as required by the Pima County Procurement Code, before any work or deliveries under the Amendment commences."

11. Replace the last sentence of Article III – Payment, with the following:

> "Total payment for this Contract shall not exceed \$935,000, of which not more than \$220,000 shall be expended during the period from 12/14/09 through 12/13/10, no more than \$220,000 shall be expended during the period from 12/14/10 through 12/13/11, no more than \$220,000 shall be expended during the period from 12/14/11 through 12/13/12,

AWASA No. 5 1 no more than \$220,000 shall be expended during the period from 12/14/12 through 12/13/13, and no more than \$55,000 shall be expended during the period from 12/14/13 through 03/13/14."

All other provisions of this Contract, not specifically changed by this Amendment, shall remain in effect and be binding upon the parties.
