*Title:

Request, pursuant to ARS 12-284.01, to expend funds from the Document and Digital Evidence and Retrieval Conversion Fund to purchase scanning equipment, printers, and upgrade the alarm system for the office of the Clerk of Superior Court in Pima County.

*Introduction/Background:

The Office of the Clerk of Superior Court is the official record keeper for the Superior Court. As such, it is charged with creating and maintaining an electronic record accessible to our office, the Court, external partners, and the public. Currently, we need printers for our Imaging Unit to replace end of life printers. We also need scanners to transition to digital email and away from fax machines and analog lines used to send documents. Our archive document storage facilities at the Mission Road complex (buildings 21 and 23) needs to have the alarm system upgraded, as it is currently inoperable.

*Discussion:

ARS 12-284.01 allows for the purchase of equipment to maintain the clerk's document storage and retrevial system using special revenue that is captured at the time filing fees are paid. This money is set aside to defray the cost of maintaining the Clerk's document storage and retrieval system and to convert to micrographcs or computer automation. The statute also requires coordination with the Superior Court Presiding Judge, which has been attached for your reference.

*Conclusion:

The Clerk of Superior Court is in need of updated printers in our Imaging Unit; scanners to transition away from analog lines and fax machines; upgraded alarm system for our Archive Unit facilities. The utilization of the mentioned special revenue fund fits the parameters of this request.

*Recommendation:

We recommend the BOS approve the request to expend \$35,427.15, from the Document and Digital Evidence and Retrieval Conversion Fund.

Re: COORDINATION TO EXPEND DOCUMENT STORAGE AND RETRIEVAL FUNDS

We are in need of purchasing new printers for our Imaging Unit. In coordination with ITSD, we have received a quote from CDW-G (attached) in the amount of \$11,401.00, including tax. The quote has no expiration date.

This need for our office fits the parameters of fund use from the Document Storage and Retrieval Special Revenue Fund, pursuant to ARS § 12-284.01. The new printers will be deployed in our Imaging Unit of the second floor.

Also, the Clerk's Office is transitioning from faxing documents on analog phone lines to scanning/emailing documents. This requires the purchase of 11 scanners for use in the Legal Records (8) and Child Support (3) units. The quote received from ITSD for the scanners is \$4,147.44 (attached Incident #98896), \$4,508.27 including tax.

This need for our office fits the parameters of fund use from the Document Storage and Retrieval Special Revenue Fund, pursuant to ARS § 12-284.01. The new scanners will be deployed in our Legal Records and Child Support units.

Additionally, the Mission Road buildings 21 and 23, that house our archive files and courtreporter notes, are in need of being upgraded to accept a new intrusion panel and network alarm communicator for each building.

This need for our office fits the parameters of fund use from the Document Storage and Retrieval Special Revenue Fund, pursuant to ARS § 12-284.01. This will bring the alarm system up to 2025 standards and make it operational.

Building 21 Facilities Management (FM) upgrade expenditures are estimated to be \$5,292.40 (attached), \$5,752.84 including tax.

Building 23 FM upgrade expenditures are estimated to be \$4,492.25 (attached), \$4,883.07 including tax.

ITSD estimated needed infrastructure and hardware costs are \$3,920.00 (email attached), **\$4,261.04** including tax.

A 15% contingency factor for all requests is \$4,620.93.

The total expected expenditures from the Document Storage and Retreival Fund is \$35,427.15.

Your coordination with this expenditure is greatly appreciated.
