ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors, establishing prima facie reasonable speed limits for motor vehicles on Wilmot Road in Pima County, Arizona. Staff recommends **APPROVAL**. (District 2,4)

The reason for this ordinance is because Davis Monthan Air Force Base (DMAFB) will be opening the New South Wilmot Gate for base personnel. According to the study (New South Gate Transportation Engineering Study, June 2007) conducted by DMAFB, the traffic projection model estimates that the South Wilmot Gate will attract 5,000 trips per day. DMAFB has requested that the speed limit on Wilmot Road approaching the New South Wilmot Gate be reduced from 50 miles per hour to 35 miles per hour and then to 25 miles per hour to comply with the military base facility standards and enhanced safety for base personnel and other roadway users. In addition, this ordinance will update and consolidate the existing speed limit ordinances for Wilmot Road.

AN ORDINANCE OF THE PIMA COUNTY BOARD OF SUPERVISORS ESTABLISHING PRIMA FACIE REASONABLE SPEED LIMITS FOR MOTOR VEHICLES ON WILMOT ROAD IN PIMA COUNTY, ARIZONA

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627, 28-701 and 28-703, as amended, to fix prima facie reasonable speed limits on through highways, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined the reasonable facie speed limits for motor vehicles on portions of Wilmot Road,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. The reasonable and safe prima facie speed limit on Wilmot Road be established as follows:

SPEED LIMIT	FROM	<u>TO.</u>
a) 50 mph	0.34 miles south of Klafter Road (City of Tucson limits)	Hermans Road (City of Tucson limits)
b) 35 mph	Valencia Road (City of Tucson limits)	0.43 miles north of Valencia Road
c) 25 mph	0.43 miles north of Valencia Road	0.57 miles north of Valencia Road (DMAFB)
d) 35 mph	Sunrise Drive	Placita Del Nido

SECTION 2. Ordinance 2008-89 is repealed and all other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highways herein listed giving notice of the prima facie reasonable speed limits.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
