Title: Law Day Proclamation, May 1, 2017

# Introduction/Background:

Law Day is celebrated in the United States of America each May 1st, pursuant to a joint resolution by Congress (36 U.S. Code - Section 113). This day was set aside to mark the Nation's heritage of justice, liberty and equality under the law. Superior Court is requesting the Board of Supervisors formally recognize these rights by proclaiming May 1, 2017 "Law Day" in Pima County.

## **Discussion:**

In conjunction with the Young Lawyers Division of the Pima County Bar Association, Superior Court commemorates Law Day each year by hosting an educational event for Pima County high school students. This year's celebration will salute "The Fourteenth Amendment: Transforming American Democracy" in recognition of the numerous contributions of one of the most often cited constitutional enactments, and provide students a chance to explore the many ways that the Fourteenth Amendment has reshaped American law and society.

#### **Conclusion:**

Formal recognition of Law Day by the Board of Supervisors will support this exceptional educational opportunity for Pima County youth, and enrich the prominence of Law Day in our community. 

#### **Recommendation:**

We respectfully recommend that the Board of Supervisors declare May 1, 2017, as "Law Day" in Pima County.

**NOW, THEREFORE, BE IT RESOLVED**, that the Pima County Board of Supervisors hereby proclaim Monday, May 1, 2017 to be:

and during this event, all citizens are urged to join with the Arizona Superior Court in Pima County in expressing gratitude for the protections afforded by the United States Constitution.
