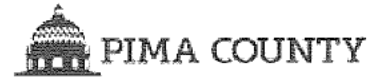

Dear Pima County Board of Supervisors,

I am writing to express my strong opposition to the proposed development of a data center in the desert southeast of Tucson. As a resident I am deeply concerned about the environmental and public health risks associated with this type of facility.

Data centers require enormous amounts of water for cooling systems. In arid regions like ours, this is an unsustainable use of a precious and limited resource. With ongoing droughts and climate uncertainty, we cannot afford to divert water from our ecosystems, agriculture, and residential needs. The operation of data centers also raises serious concerns about public health. The water used to cool these data centers is filled with contaminants, poisons groundwater. This poses risks to Tucson residents—especially vulnerable populations such as children and the elderly. Additionally, data centers are often built without sufficient environmental oversight or emergency planning for accidents or leaks involving hazardous materials. These projects offer minimal long-term benefits to the community while introducing disproportionate environmental burdens and health hazards. This project is better suited to an environment outside of the desert, where water is not as scarce.

I urge you to protect our natural resources and the well-being of your constituents by opposing this data center proposal. Thank you for your attention and leadership on this critical issue.

To Pima County Board of Supervisors:

Please hold off making a decision on the Project Blue data center proposal. The project will make serious demands on Tucson's water and energy supplies. Not enough information has been provided for you to make such an important decision.

The secretive nature of the proposal and the process surrounding it is very troubling.

That such a project can be "water-positive" has not been demonstrated. Project Blue will draw on groundwater supplies -- a bad idea. The proposed use of "reclaimed" water is no solution. Reclaimed water is not water that would otherwise be "wasted" -- reclaimed water can also be used for environmental restoration, or, in the future, can be treated to potable standards.

Data centers are notorious for their power consumption. Why not require solar panels and batteries to supply at least some of the facility's power? Until TEP generates 100% of its power from renewable sources, generating more power will generate more greenhouse gases.

Don't approve this proposed sale until the developers provide more information. This is a high-impact project. You, and the residents of Pima County, have been kept in the dark.

Dear Esteemed Pima County Board,

I am emailing today with my concerns surrounding the proposed Project Blue project slated for development near Pima County Fairgrounds. I get that Pima County is trying to compete with its Phoenix neighbors, but maintain that this is a horrible idea that will strip more natural resources than provide benefit to the community at large.

I have concerns whether such a data facility using such a large amount of water in a desert environment is appropriate use of such a limited commodity given larger issues in the region, namely declining water availability from the Colorado River, climate change, ongoing drought, and continued development of this region. It looks as though the developer is making it look good on paper, but Tucson, and Pima County have worked long and hard to preserve natural resources, and I question the motives of this developer with its interim intent of tapping into the existing water supply. The "eventual" goal of being 100% reclaimed water does not go far enough to articulate how and when that will be achieved, and there is a lot of wiggle room in ambiguity. I would challenge the developer to be restricted to an allotted amount of water and not not be charged a reduced rate for such water use.

Dear Pima County Supervisors and County Administrator,

Please hold off on a decision on the Project Blue data center proposal. It looks as if you haven't been given enough information to make such a decision. Don't buy a pig in a poke.

Moreover, the secrecy surrounding the proposal and the process of decision-making is very troubling. It's very hard for Pima County residents to provide substantive comments because the requisite information has not been shared with the public. Until we have more information – vote NO.

Why? The project will make serious demands on Tucson's water and energy supplies.

Data centers are notorious for their power consumption.

What's been reported in the press sounds as if the developers are going to get solar power from TEP – maybe by funding more solar production by TEP. County Administrator Leshner's memo suggests this project "will promote overall reliability." I think she's alluding to developing more electricity infrastructure, including the tall high-voltage lines that are undesirable. That doesn't improve reliability. That just gives more money to TEP.

I oppose this project – don't tell us it will improve reliability. If the County insists on approving this project, the very least the County should do is require the data center group to supply its own power through installing their own solar power and their own battery storage. That would give the project reliability. Otherwise, you're just authorizing TEP to earn more money.



As for this proposed project to be "water-positive," that's really, really hard to believe. Touting the idea of "reclaimed water" sounds good at first read, but upon further consideration -- it's really a shell game. Taking potable water and turning into "reclaimed water" isn't "water-positive." It doesn't generate more water -- it just turns potable water into non-potable water -- a net loss.

I oppose this project. The County hasn't provided Pima County residents enough information about this project so that we can provide reasoned comments. It also sounds as if the Pima County Supervisors themselves have not been given enough information to consider this project.

Don't buy this pig in a poke -- and don't foist it on county residents.

Dear Supervisors: While I am generally in favor of infrastructure improvements, the lack of specifics on the proposed data center is concerning. The Daily Star (June 12) reported:

"It (county administrator Leshner's memo) gives no details, for instance, on how the project would recoup its future water uses to achieve its goal of being "water positive." It doesn't explain how the project would protect existing TEP ratepayers. It doesn't say how big the reclaimed water line to be built to the data center site would be or how the site could meet a commitment not to take reclaimed water away from any existing uses including water recharged daily into the Santa Cruz River.

"Pima County officials, citing a non-disclosure agreement they made with Project Blue developers, have declined to release specifics on the project's water or energy use."

The unanswered questions about the proposed project are material to a decision to go ahead, and important for the public as well as county decision makers to know. I ask that all who will vote at the Board of Supervisors meeting on June 17 press the developers to provide more detail on the identified issues and provide the answers to their constituents.

Do not give a rubber stamp to these proposals before all relevant questions are answered in detail. Delay is preferable to rushing into a costly commitment, which also carries huge environmental risks.
