

Let me express my strong objection towards your pretension of imposing a mask mandate in all K-12 public and private schools in Pima County. How dare you want to break a Governor's law?







A place where nearly no teachers or children are wearing masks at a time when she and her medical issues most require them to do so. I am writing to implore that you pass a masking mandate for our schools in Pima County, knowing that what I ask will pit you against the governor and lock you in a legal battle. A battle which I believe is necessary, and winnable.

The law that was passed was unjust. We are to provide a safe and effective learning environment in our public schools. Masks are safe. They help prevent the spread of a deadly virus that is currently spreading unchecked. They don't negatively impact education. They allow for in school learning They don't increase carbon dioxide levels. Kids tolerate them better than fully grown adults, it seems. Our kids under age 12 have not had a choice to be vaccinated as the vaccine is not yet available to those in that age groups.

My name is Brent Watkins and I am a pediatrician at Tanque Verde Pediatrics.

I would like to share my experience over the past month and express that I strongly support a mask and vaccine mandate.

Since the beginning of the 2021-2022 school year for the Vail School District, our practice has been inundated with sick visits. A small but increasingly significant percentage of these are COVID positive. A large and significant percentage are visits related to other illnesses with responsible parents who are trying to rule out COVID to help contain spread.

The burden that these sick visits are putting on our office and on our patients' families cannot be understated. We know that masks decrease the risk of transmission of COVID as well as other viruses. We know that in-person school continues to be the gold standard for our children. We know that vaccines decrease illness severity and COVID hospitalizations.






Dear Pima County Supervisors,

Or at the very least, un-tie the hands of school districts and the University so that they may be able to employ proven mitigating protocols for the safe return to school. Please consider:

COVID-19 case rates and hospitalizations continue to increase markedly. Vaccination rates have slowed, and children under 12 will not have access to vaccine until "mid-winter." The Arizona Academy of Family Physicians, along with the CDC, the American Academy of Pediatrics, just joined their voice to the growing numbers that are publicly pleading for the wearing of face masks to prevent transmission: "All students greater than 2 years old, school staff, volunteers and visitors should wear face masks while indoors at school, unless medical or developmental conditions prohibit mask use. This is a proven strategy to keep students and teachers as safe as possible while away from their homes." It took many parents the length of this ongoing pandemic through so many hardships to feel that it was safe to return their children to school, that it was necessary, and with the mitigating protocols employed by schools as they opened up slowly, we felt reassurance. It was a slap in the face that the governor and legislators would prevent schools to continue employing this simple, free, and proven protocol. It is nothing short of shooting themselves in the foot, carelessly and without conscience, making this cruel decision. If it weren't so dangerous it would be laughable. It so contradicts the intention to keep the economy going. It is an undue burden on children, parents, educators, and the community as a whole.

Illness from this preventable disease will continue to upend students' academic and social worlds. School communities will be thrown into chaos with the inevitable coming and going, opening and closing, of learning opportunities and school activities. We are already seeing that in other school districts - Marana and Vail have had a significant number of infections. Parents who feel inconvenienced now by masks will be truly burdened, as will we all, when their children are not able to access a regular school year. Consider the stress levels of being in an unsafe learning environment. Why endanger everyone's hard work and perseverance to this point?

We know that face masks are an effective way to mitigate transmission of the SARS-CoV2 virus. Look at CFSD's record during the last school year, when everyone was required to wear a mask. The mitigation was a success with little to no transmission except for the athletics where it was more difficult for kids to wear their masks. (Or where mask wearing became too relaxed.)

As a contrary example, we are already seeing reports of significant virus transmission at various nearby schools that have opened without a mask mandate. Vail, for example, had 25 cases in nine days. As of 1 Aug 2021 (the latest date available) they have had 57 students and 12 staff members test positive. (The number might indeed be higher, as those who are ill may not get a test, or if they do, they don't report the results.)

Pima County has done hard things before - you have the power to lead and ensure a safe environment for everyone. It is unconscionable that politics drive our governor's and others' demands that school districts cannot require everyone on their campuses to use this simple, inexpensive and effective method of reducing virus transmission. It is time to be bold, and lean into the service you elected to commit to. Let your actions speak for you. Our University is doing everything possible to encourage mask wearing short of requiring because as a science driven institution, it knows masks work, you know masks work. It is time to put the fear of retribution aside and do what is right. Know that the majority of parents and children would support you in this very difficult stance. We have been proud of Pima County throughout this pandemic - make us proud again.

Mask Mandate Plea: Teacher Perspective



Good afternoon,

As a middle school teacher at a local school district, I am writing to you as a plea to mandate masks in Pima County schools. At my district, the guidance is that masks are strongly encouraged and recommended, but ultimately the choice rests on parents and guardians. On the first day, Monday, 8/2, I observed approximately 50% of students wearing masks, which was better than I anticipated. By Friday, however, I observed approximately 20-25% of students wearing masks.

I teach 5 classes, and 4 of 5 of them are jam-packed. All seats are full, except for one class. So I ask, would you want your child in my classroom where maybe 25% of students are masked? I'd imagine not if you're taking this virus seriously. Rest-assured, I am fully vaccinated and wear a mask because I do not want to contract the Delta variant and transmit it to my students or anyone else. I also want to support those families who are taking this virus seriously, as it's been made abundantly clear that in the community where I teach, many are not, and this is extremely unsettling, uncomfortable, and demoralizing. I pour my heart and soul into teaching my students, instilling a love of learning, creating a warm and supportive classroom community and culture, and to be completely honest, I feel let down by this community. Many do not have our greatest treasure top of mind--our children. People have chosen a myriad of reasons to not follow the science, and this is gravely concerning.

The CDC's original guidance post-vaccines was that if you're vaccinated you don't have to wear a mask. If you're not, then wear one. That's it. Sadly, many of the non-vaccinated chose to imply they were vaccinated by not wearing a mask, and here we are. We take a step forward, just to take five steps back, all at the behest of those who chose to ride on the backs of those of us doing everything right--the community-minded, the well-informed, the socially responsible. We understand that our behavior directly impacts others. Hence, we do what we need to do to ensure we're doing our part. I am deeply concerned that, now, the children have become the pawns. They trust their parents/guardians and their community to protect them and make the right decisions that keep them safe and healthy. I can say with complete confidence that it is not safe in my classroom. I'm doing everything I can to maintain and promote cleanliness (disinfecting, distancing pods/groups, sanitizing, hand-washing, wearing my mask, etc.); however, this endeavor cannot rest solely on the backs of those of us who are taking this seriously. There simply isn't enough of us.

That said, I need you to be our voice and send the message to our students that they matter. We all learned that remote and hybrid learning are detrimental to most children. We need to remain in-person. We cannot pivot back, but I am worried that it's just a matter of time before we do. Mandating masks could prevent this outcome, though. Children have an amazing ability to adapt. If all are masking, all will mask. Unfortunately, if some are masking, the maskers will slowly dwindle, as I observed the first week back. There is a lot of peer pressure that influences the students to mask or not. It's been made abundantly clear that when given the opportunity to choose, the choices of many have been at the detriment of children. I submit to you: choose children. It's time to stand up to misinformation, anti-science, and egocentrism.
