Fiscal Year 2018/19 Budget Hearing Schedule

Background

At the March 6, 2018 Board of Supervisors meeting, the Board voted to hold five budget hearing sessions on the Fiscal Year (FY) 2018/19 Pima County Budget. Hearing sessions are scheduled for May 1 (half-day, afternoon), May 8 (full-day, two sessions, morning and afternoon), May 15 (half-day, afternoon) and May 16 (half-day, afternoon).

Attached is a proposed schedule for the departments that are to present their budgets at these hearings.

Each scheduled department will discuss the following aspects of their budgets:

- Recommended operating department expenditures, revenues and operating transfers;
- Major programs and related services provided by the department;
- Major costs of providing programs and related services by the department;
- Significant changes in the recommended FY 2018/19 budget versus the FY 2017/18 adopted budget; and
- Major budget issues the department is facing in FY 2018/19.

The information provided by the departments at these hearings will be based on the FY 2018/19 County Administrator Recommended Budget that will be distributed to the Board of Supervisors on April 27, 2018. Working Budget Drafts for each County department and budget unit are also available on the [County's Budget Website](#) .

Note that several smaller County departments, such as each of the five Board of Supervisors budget units, the Clerk of the Board, Real Property, etc. are not scheduled for a hearing date to help make more efficient use of the Board's time. These departments are relatively small and are mainly administrative in function. Each of these departments have simple and straightforward budgets that experience minimal fluctuations from year-to-year. A list of the nine departments not scheduled for presenting is available on the last page of the attached hearing schedule.

Recommendation

In order for departments to be able to timely prepare for discussions of their budgets, I am requesting that the Board of Supervisors approve the attached schedule for the upcoming budget hearing sessions.
