ITEM SUMMARY, JUSTIFICATION and/or SPECIAL CONSIDERATIONS:

ORDINANCE NO. 2013 - ____, An ordinance of the Pima County Board of Supervisors regulating parking on Albany Avenue in Pima County, Arizona. Staff recommends **APPROVAL**. (District 1)

The reason for this ordinance is that vehicles parked on both sides of Albany Avenue are causing safety issues related to sight distance and inhibiting through traffic. Albany Avenue is south of Legacy Traditional Charter School off of Cortaro Farms Road. Vehicles are currently parking along both sides of Albany Avenue during school arrival and dismissal to drop off students. The students and parents utilize the HAWK flasher currently installed across Cortaro Farms Road to access the school.



**AN ORDINANCE OF THE PIMA COUNTY BOARD OF
SUPERVISORS REGULATING PARKING ON ALBANY
AVENUE IN PIMA COUNTY, ARIZONA**

WHEREAS, the Board of Supervisors of Pima County, Arizona, has the authority under Title 28 of the Arizona Revised Statutes, more specifically Sections 28-627 and 28-873, as amended, to regulate the stopping, standing or parking of vehicles, and

WHEREAS, the Board of Supervisors of Pima County, Arizona, has determined that it is in the interest of public safety that vehicles should not park at any time on Albany Avenue from Cortaro Farms Road to Washakie Way,

THEREFORE, IT IS HEREBY ORDAINED by the Board of Supervisors of Pima County, Arizona, that:

SECTION 1. Parking on both sides of Albany Avenue from Cortaro Farms Road to Washakie Way be regulated No Stopping, Standing or Parking Anytime.

SECTION 2. All other ordinances or parts of ordinances in conflict herewith are superseded to the extent of such conflicts.

SECTION 3. This ordinance shall take effect when and to the extent that signs are posted on the highway herein listed giving notice of the parking restriction.

SECTION 4. Violators of this ordinance shall be subject to civil or criminal sanctions as provided by law.

SECTION 5. The various county officers and employees are authorized and directed to perform all acts necessary or desirable to give effect to this ordinance.
