As a result of the Pima County Traffic Engineering Division's traffic control plan review, road closures, including potential detour routes if needed due to inclement weather or other circumstances, are recommended to facilitate the event.

Conclusion:

Pima County Traffic Engineering recommends the temporary closure of portions of Silverbell Road between Ina Road and Sweetwater Drive to enhance the safety of the El Tour De Tucson event by reducing potential vehicular conflicts.
